**AB 247 (Muratsuchi, Fong & Wilson)** Summary: Places a statewide K-14 educational facilities bond on a 2024 statewide ballot providing \$14 billion to K-12 schools and community colleges for building and repairing educational

facilities.

Status: Introduced

Alignment with goals: Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

**AB 3015 (Ramos)** Summary: Provides residency to students from neighboring Indian tribes.

Status: 2/17/24 - From printer. May be heard in Committee on March 18.

**AB 1885 (Addis)** Summary: This bill would make qualifying for the Student Success Completion Grant (SSCG) more equitable by requiring participating community colleges to also consider awarding a grant to eligible students who enroll in 9 or more units per semester, or the quarterly equivalent, who are considered full-time as part of a disabled student programs and services Academic Accommodation Plan.

Status: 2/5/24 - Referred to Committee on Higher Education.

**AB 1818 (Jackson)** Summary: This bill would require each campus of the California State University and the California Community Colleges, and would request the University of California, to allow overnight parking by a student attending its campus if the student uses the vehicle as housing, the student has a valid parking permit issued by the campus, and the vehicle is parked in or on a campus-owned and controlled parking lot or parking structure.

**AB 2093 (Santiago)** Summary: This bill would extend the term of eligibility of the California College Promise Grant for an additional 2 academic years for first-time community college students and returning community college students who matriculate into upper division coursework of a community college baccalaureate degree program. The bill also would add to the funding formula, for funding appropriated for the program in excess of the funding needed to waive all student fees, the number of students who matriculate into upper division coursework of a community college baccalaureate degree program

**AB 2104 (Soria) & SB 895 (Roth)** Summary: Authorizes CCCs to offer BSNs on a pilot basis.

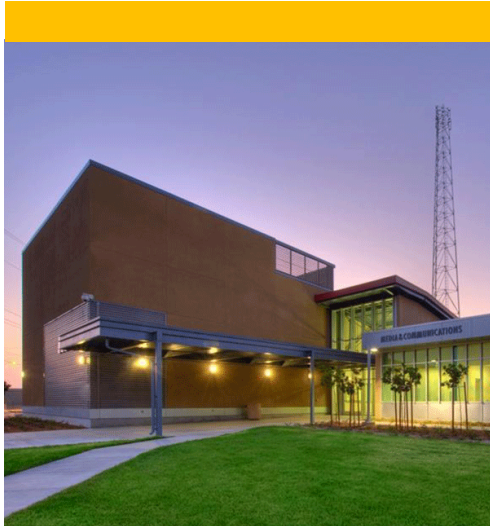
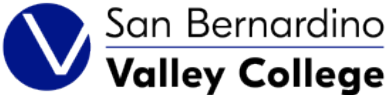

# Top Sacramento Updates

---

- **The Governor's May Budget Revision is set to be released by May 14th.**
- Assemblymember Bill Essayli was replaced on the Assembly Budget Subcommittee #3 on Education Finance and was replaced by **Assemblymember Greg Wallis**. Wallis represents the Crafton Hills College area.
- **Both the Assembly and Senate Appropriations Committees** will meet on Thursday, May 16 to go over the suspense files and announce which bills will continue to move through the legislative process.
- **Both of the nursing bachelor's degree bills**, SB 895 (Roth) and AB 2104 (Soria) will go to the suspense file where they will be heard with all the bills in the suspense file on May 16.

# 2024 SBCCD Advocacy Priorities

## OPPOSED LEGISLATION

### AB 1818 (Jackson)

**Summary:** This bill would require each campus of the California State University and the California Community Colleges, and would request the University of California, to allow overnight parking by a student attending its campus if the student uses the vehicle as housing, the student has a valid parking permit issued by the campus, and the vehicle is parked in or on a campus-owned and controlled parking lot or parking structure.

**Status:** 4/22/24 - Referred to Appropriations Committee

### AB 2088 (McCarthy)

**Summary:** This bill would require the governing boards of school and Community College District, to offer with priority, vacant part- and full-time positions to current regular nonprobationary classified employees who meet the minimum job qualifications of the position at the time of application.

### SB 1388 (Archuleta)

**Summary:** This bill establishes an annual 16.7 percent reserve cap for a community college district, unless the district participates in specified employee benefit programs and has at least 75 percent of instruction taught by full-time instructors.
