Negotiations Update

Wages

- The district has responded to our wage proposal with a counteroffer of 3% for the 2025-2026 year, along with an additional 3% (or an equivalent monetary amount) for the 2026-2027 year to address specific negotiation needs related to wages. For full-time employees, they have proposed a retroactive 1% raise for the 2024-2025 year, which has already been provided to part-time employees under the previous agreement.

- The negotiations team is encouraged by the district's verbal commitment to move toward reaching the median wage and their interest in pursuing a multi-year agreement. We will continue to keep you updated as discussions progress.

Coaching and Chair Stipend

Further work is needed to determine reassign time and stipends for both chairs and coaches. While we do not want to rush to reach an agreement, we recognize the importance of addressing the fact that these stipends have not been reviewed in several years. In the interim, and as we work towards a permanent solution, the district agreed to a one-time stipend of \$900 a semester for the 2024-2025 year. Eligibility details available on the union website.
