## Approval of Minutes of April 18, 2013

## **Environmental Scan Update**

Madrid Consulting finished the first draft of the environmental scan and this has been forwarded to the college presidents and researchers for review. The plan is for each college to spend approximately two weeks selecting the aspects most important to the planning processed base on the Mission, Vision, Values, etc. already determined by the committee. These high level issues would then be discussed with the Board at the July 25 meeting. Keith mentioned that he found that the scan data did in fact require revision and he was working directly with Henry Madrid on resolving several issues for CHC. Charlie requested James work with Henry on any SBVC issues.

Once the quality/content matters are settled, it can be determined if the environmental scan data can be part of the July 25 board presentation. It was decided that the environmental scan would be posted online somewhere that the DSPC members could access and review the data, albeit still in draft form.
