Mr. Baron said if we want to restore some of the sections, we can do that with the reserve; however, we are only getting by this year because we under spent. Next year we could be looking at layoffs or further reductions in classes. He said we need to look at the short and long-term impact on the district.

Mr. Longville said he appreciates the fact that staff wants to conserve the reserve as much as possible, but the whole point of having a reserve is it is available when times get tough and suggested we take advantage of the reserve in a modest way.

The chancellor said he would address the trustees' concerns after he reviews them with his cabinet.
