### REPORTS

Trustee Ferracone had questions for the Chancellor. The Strategic Plan didn't appear in redline format. She requested all future altered documents to appear in redline format. Board members should be on the Strategic Planning Committee and Accreditation Ad Hoc Task Force and include on agenda to have discussion. Thought we should have a different policy for hiring of college president. BP 7250 shows Chancellor, VC, and college presidents are Executive Officers of the District. The Board Ad Hoc committee should meet with consultant to develop a policy. Her specific issue is that the policy says that the majority of the members shall be those with applicable knowledge in the job category of classification with at least one member being from the affected department, but that the screening committee shall have at least one management member. Trustee Ferracone feels we shouldn't hire an executive administrator without a senior manager on that committee. Trustee Williams attended Linked Learning to secure \$6M from the James Irvine Foundation. There are nine different schools within the Inland Empire that are participating. The concept is to make classroom learning more applied. He would like to see the District more involved in education processes in the community. Thomas Morales spoke at Sunrise Rotary about the Master Plan at CSUSB and growth of CSUSB. Trustee Williams wanted to know what campuses are doing about safety given the happenings at Cal State. Trustee Williams asked for personnel involved in workforce issues to send their concerns so that they can be sent to the State Chancellor's Office. President Longville attended Inspiring Success lunch at Valley. He is proud to be a part of an institution that lifts up students. He also attended the March in March event in Sacramento. Trustee Harrison attended Rialto Women's event, Rialto BPW, and Latin American Women's event that talked about women's stories. She attended Sunset Rotary to hear President Morales about their strategic plan that included input from the community and campus people. She also attended the State of the City and will serve and participate in the traveling show where they talk about the good things happening in the city and the challenges. She will be part of the 17 member strategic planning committee for the City of San Bernardino. Trustee Harrison agrees with Trustee Ferracone about the District's Strategic Plan and that the trustees have to be involved and the District leadership has to take on the responsibility. Trustee Ferracone asked the Chancellor when the board would receive a completed Enrollment Management report completed by the Brain Trust. Chancellor will send the raw report to the trustees.

Trustee Guzman attended Inland Empire Black Chamber of Commerce meeting. SCTA read to elementary students. They hosted a teachers forum on how to become a teacher or professor. Leadership conference is taking place at SBVC. On April 1 there will be a self-defense class hosted by the District. Trustee Panaguiton held a high school visitation day, gave campus tours, and held a small session about student government.

Chancellor addressed the concerns about security. He said the Police Dept. sent a blast to faculty, staff, and students regarding information about what was happening at CSUSB just so we can be aware of the issues happening and be on alert. The email included a composite drawing of the suspect. The District is hosting a self-defense class at Crafton and Valley on how to protect yourself. In addition, we are increasing patrol around both campuses and are in touch with our community police departments to assist with patrols. The update on Accreditation Action Report highlights steps that are being taken to address District issues from ACCJC. The first update is mentioned of the Ad Hoc Task Force, with shared governance representation, to develop a tactical plan to address the recommendations. We are receiving interest from groups we've never heard from to participate on the Ad Hoc Task Force. The Chancellor attended the Inspiring Success Luncheon. Chancellor Baron. Trustee Longville, and Trustee Zoumbos were recognized at the IEEP Dinner for the Local Hire program and Energy Efficiency program.

President Fisher is proud of the growth of the Inspiring Success luncheon. Over 500 students have graduated from the middle college high school program since it started. The college's strategic plan must align with the District's plan. SBVC is working toward the integration of the student equity plan, the basic skills plan, he enrollment management plan, and technology plan. The commission is looking at whether or not we evaluated the evaluation. Administering community college survey of student engagement. The results will allow SBVC benchmark measures for student/faculty engagement. It will help to meet targets for student success. Sponsoring an educational summit at SBVC on April 1 to encourage the community to be a part of the

conversation as they update their strategic plan. Child Development Center had a Dr. Seuss Day connected to reading, which is the foundation for learning.

Aaron Beavor introduced himself as the new Classified Senate President. Sending six people to Leadership Training from the classified senate budget. President Fisher is funding two additional students to be able to attend. He reported the blue phones all work and lights around the campus are being upgraded. Associated Student representative, Gabriel Jaramillo reported ASG had March in March event in Sacramento. Thanked President Longville and Cheryl Brown for taking care of the room and Assembly member Brown for purchasing lunch. Upcoming events include Clash of the Clubs on April 23, Student Appreciation Day on April 29, and General Assembly with Student Senate for California Community Colleges on May 1-3. ASG approved to bring in more color with 40 flags for the poles in the walkway. ASG is working on increasing student participation.

President Marshall reported CHC is at 90 percent on programs. Crafton Council approved agenda for Flex Day on April 1 where they will discuss outcomes assessment and broad dialogue on ILOs, GEOs, and related items. Had a ½ day planning session with Yucaipa/Calimesa School District. Working with them on Health and Biomedical Pathways and looking into Engineering and Public Safety. Looking at expanding programs in relation to Linked Learning. As the representative of Region 9, she has the opportunity to attend the Apple Headquarter in Cupertino and how to partner with them as community colleges.

Denise Allen reported CHC is doing midterms this week and spring break next week. Have had a couple of meetings on the three peaks challenge. Marathon will take place on May 9. CHC Senate approved instructional support chair support position, moved forward with a Distributed Education position, had a presentation about outsourcing the bookstore. Looking for more information on how it would impact students. District Assembly made a recommendation to have the colleges look at a noncredit program. Both Senates will look at how the conversation will evolve. CHC is moving forward with hiring process. They are looking forward to additional full time faculty members. Flex day is upcoming with ILOs as a topic of conversation. Denise attended joint district strategic plan meeting. Academic Senate voted to move forward with the same process as SBVC with the vote of no confidence. Goal is to have a resolution to the board in April. Trustee Williams asked to be updated on the bookstore. Michele Tinoco had meeting on Classified Professionals Week. Luncheon is June 11 in LRC 226 from 11:301:30. Scholarship committee for classified employee scholarships met and will give two scholarships. Aaron Burgess announced he attended Women's Appreciation Day on February 20. Held High School Senior Day and Club Rush.

Sarah Miller spoke for CSEA. She read a written report to bring matters to the board. Health & Life Science regarding indoor air quality. Mr. Eation reported the recent testing of the facility was aborted due to dirty HVAC filters. CSEA discovered that a separate ventilation system at the SBVC morgue was not operating correctly because the battery was dead. CSEA is willing to provide evidence to the Board that the ventilation issues at the HLS Building is long standing. The timing and the types of testing scheduled for March 27 are not coordinated with the actions and activities of the department and are not likely to produce meaningful results. CSEA is concerned of the chemical hygiene training provided to employees. Glutaraldehyde was purchased, delivered, and ultimately removed from the morgue. SBVC is short of maintenance staff and as a result, the quality of life and safety is being compromised. Trustee Henry requested that Sarah send the itemized letter be to the Chancellor and then it be forwarded to the board. Trustee Henry asked the Chancellor to investigate the items addressed and report back to the board.
