WHAT IS PROGRAM REVIEW?

 A systematic, objective, and transparent process of evaluation and self-evaluation of how effectively programs/service areas are working, as part of the ongoing pursuit of higher levels of quality, achievement and service.

HISTORY OF DISTRICT PROGRAM REVIEW

- Relatively new (about 7 years)
- Brought about need for
 - Addressing accreditation requirements
 - Greater expectations of transparency
 - · Need to align district expenditures with the needs of the colleges
 - Need to integrate budget with other planning processes of the District
- No consistent point of responsibility
- Improving through better alignment with colleges, use of effective practices, and integration with District-wide planning processes

DISTRICT SERVICES PLANNING AND PROGRAM REVIEW COMMITTEE MEMBERSHIP

- One manager and one staff from TESS, KVCR, EDCT, Police, Human Resources, Business Services, and Fiscal Services.
- One representative from each Colleges' Program Review Committees.

THE PROGRAM REVIEW PROCESS

- Departments working collaboratively to reflect on their programs and develop prioritized goals, objectives, and activities (handouts);
- Area Vice-Chancellors and managers, through discussion with their department leaders, consolidate/prioritize objectives and submit to District Services Planning and Program Review Committee (DSPPRC);

THE PROGRAM REVIEW PROCESS

- DSPPRC along with representatives from the Colleges' Program Review Committees prioritize District Services objectives for resource allocation and submits to District Budget Committee (DBC) and Chancellor;
- DBC reviews the prioritized objectives and submits recommendation to Chancellor;

THE PROGRAM REVIEW PROCESS

- Chancellor's Cabinet uses the DSPPRC prioritized objectives and reviews the recommendations from DBC to finalize the prioritization and communicates to the District community;
- Prioritization of objectives informs resource allocation in the following year. The District community receives updates on progress towards the previous year's prioritized objectives.

WHERE ARE WE IN THE PROCESS NOW?

- DSPPRC has finalized its work and forwarded the recommended prioritized list to the Chancellor and Vice-Chancellor of Fiscal and Business Services;
- Will be brought to the District Budget Committee for discussion and developing a formalized recommendation to the Chancellor.

AREAS FOR IMPROVEMENT

- Better integration with college planning and focus on empowering colleges to achieve their Educational Master Plans;
 - ACCJC Task Force working on timeline to logically link college needs of the District as a primary focus of District Program Review;
- Need to document and communication process

AREAS FOR IMPROVEMENT

- Need to communicate what gets prioritizes and link to Colleges Needs, Board Imperatives, State Mandates, etc
- Better annual review, discussion, and communication of impact and success of prioritized Goals and Objectives of each service area;
- Need to build in redundancies and provide ongoing training.
