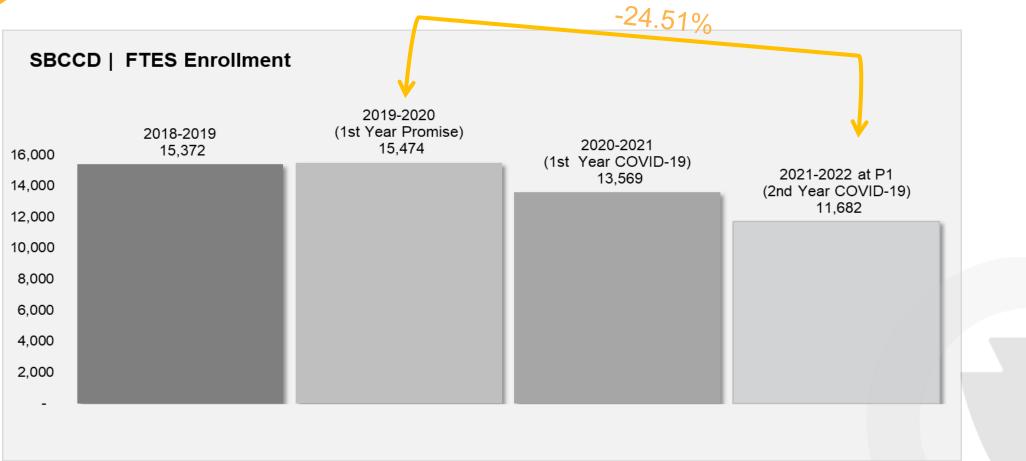

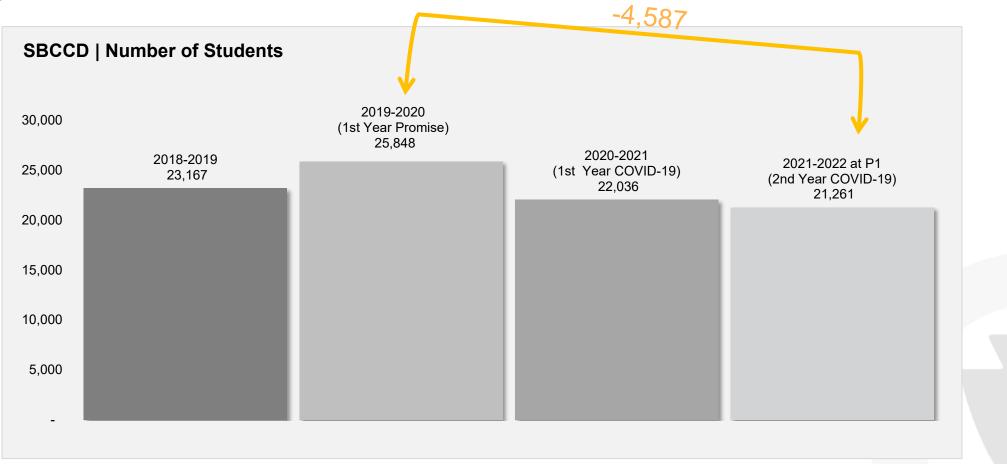


#### SBCCD ENROLLMEMT | FTES
