The principles outlined below will serve as a basis by which the SBCCD Board of Trustees will direct the Board Legislative Committee and the Chancellor's Office to evaluate local, state and federal policy proposals and recommend action to support, oppose or remain neutral.

Equity: Research indicates that student success improves when faculty and staff reflect the diversity of students. The SBCCD Board of Trustees supports public policies that increase student success, including completion, transfer and employment, while closing equity gaps and nurturing an anti-racist educational environment.

Increased Public Investment in Student Success: The SBCCD Board of Trustees supports increased state and federal funding, resources and legislation that strengthens our colleges' ability to meet student equity and workforce development goals.-consistent with the California Community Colleges Vision for Success.

College Affordability & Student Basic Needs – The SBCCD Board of Trustees supports financial aid reforms to make college more affordable, and measures to address student basic needs <u>including, but not limited to</u>, homelessness, food insecurity, mental health, and the digital divide.

Local GovernanceLocal Decision-Making: The SBCCD Board of Trustees supports local governanceaffirms its responsibility to make decisions in the best interest of the local community, district and campuses. The Board of Trustees in general, will take a position on legislative matters affecting board operations and regional decision-makinglocal control in board operations and policymaking.

State and Federal Partnerships – The SBCCD Board of Trustees will engage on legislation where the <u>justification need</u> for state or federal intervention is <u>compellingjustified</u>, and where the Board of Trustees' position is supported by available data and evidence.

<u>**Civic</u>** Engagement: The SBCCD Board of Trustees will advocate for adequate representation by the San Bernardino Community College District on appropriate boards, commissions, task forces, study groups, and other bodies that may have an impact on its educational mission.</u>

Talking Points: Put together background information and talking points for district representative meetings with Legislators and staff.


Drafting Correspondence: Assist in the development of letters and emails and official correspondence from the district to Legislators and staff.



Proposition 98

2020-21 funding for California K-12 schools and community colleges dollars in billions

Funding for Proposition 98, determining how much state revenue goes to K-12 schools and community colleges, projected to drop substantially in 2020-21. To raise funding to 2019-20 levels, Gov. Gavin Newsom and the Legislature projected to let schools and community colleges spend \$11 billion more than what is budgeted but defer payment (deferrals) for a year. K-12 schools will also get federal funding to cope with the pandemic.
