IV. CURRENT ISSUES UPDATE

A. State Budget Update Presentation by Mark MacDonald of MGI Advocacy, Inc. Mark MacDonald, MGI Advocacy, Inc. present an update regarding the 2021-22 State Budget.

Immediate and early adoption package:

- Governor proposes two sets of packages that he wants adopted prior to the normal passage of the budget in June by the Legislature:
 - Immediate Adoption (Next Two Weeks)
 - \$2 billion for safe return to in-person instruction for K-6 instruction
 - Early Adoption (Early Spring)
 - \$100 million for immediate emergency financial assistance to community college students
 - \$20 million to boost retention and enrollment rates for community colleges

Deferrals:

- Repays \$1.1 billion in 2021-22 deferrals
- Remaining \$326.5 million in deferred funding for 2021-22

Apportionments:

- \$111.1 million for 1.5% COLA to SCFFF
- \$23.1 million for .5% Growth

Ongoing Funding:

- \$30 million Online Technology and Mental Health Services
- \$10.6 million online education ecosystem and infrastructure
- \$15 million California Apprenticeship Initiative
- \$6.1 million COLA to certain categorical programs
- \$8 million increased operating costs for broadband through CENIC
- \$8.1 million COLA Adult Education Block Grant

Ongoing Funding:

- \$150 million Emergency Financial Aid for Students (in addition to \$100 million proposed in Early Adoption package)
- \$100 million Emergency Grants for Food and Housing Insecurity
- \$20 million expand Work-Based Learning
- \$20 million Faculty Professional Development
- \$15 million Zero-Degree Textbooks
- \$2.5 million Dual Enrollment Instructional Materials
- \$600,000 Implementation of CSU Ethnic Studies requirement (AB 1460 Weber)

Facilities:

- One new start project
- 17 continuing projects
- Administration plans to approve more facilities to go to the funding phase in the Spring.

Other Initiatives:

- Require all high school seniors to fill out a FASFA or California Dream Act Application
- Increase Competitive Cal Grants by 9,000 to 50,000
- Buy down employer contributions for retirement funds by approximately two percentage points each (CalSTRS 18.1% to 15.92%/CalPERS 24.9% to 23%)
- Community college districts required to maintain number of online courses in 2021-22 that is 10% higher than the number offered in 2018-19
- \$250 million one-time general fund to support forthcoming proposals focused on workforce development, segment alignment, and improving linkages between higher education and the workforce.

Issues and Questions:

- Community college districts are provided with significant funding augmentations, however, most of that funding is one-time.
- Community college districts did not receive a COLA last year, and that COLA is not "made up" in this proposal.
- Most of the one-time funding is earmarked for financial aid, there is not much operational funding including funds that districts would need to open campuses.
- Is there a way to increase base funding and provide additional flexibility in the one-time funding that the Administration is proposing.

B. 2021-22 State Budget Priorities (Information Only)

Interim Chancellor Torres reviewed the SBCCD 2021-22 State Budget Priorities. 1.5% COLA for SBCCD, and K-12 will be receiving 3%-3.5% COLA. Mark MacDonald to get clarification regarding 4-year universities receiving ongoing funding. SBCCD has approximately \$30M in deferrals, and the State is to pay approx. 2/3 back. It is important to SBCCD to support the CALPERS and CALSTERS paydown. Chancellor Torres clarified PERS and STERS. The rates will be the same. The only difference is the State will pay a portion on SBCCD's behalf. This is considered one-time funding but has been ongoing for the past two years and will continue this year.

Interim Chancellor Torres discussed the possibility of putting the one-time funding into a flexible block grant that each college can us and assist with student's basic needs. From the federal level, we know we will be receiving about \$18M, but we are unaware of the restrictions of those funds at this time.

Angel Rodriguez will be scheduling advocacy Zoom meetings with our local leaders via Zoom in lieu of traveling to Sacramento.

2021 Bills of Interest

Overview: The California State Legislature reconvened from Winter Recess on January 11. Of the 545 new bills already introduced by the legislature, 51 bills relate to higher education. Of these bills, 15 could have a direct impact on California community colleges, our faculty, and students. Below is a summary of legislative proposals with staff recommendations.

Key Legislative Dates:

- Feb. 19 Last day for bills to be introduced
- June 4 Last day for Senate and Assembly to pass bills introduced in that house
- June 15 Budget bill must be passed by midnight
- September 10 Last day for any bill to be passed

AB 99 (Irwin): Statewide Cradle to Career Data

Staff recommendation: Monitor

AB 102 (Holden): Dual Enrollment

Board Legislative Principle: State and Federal Partnerships

Staff Recommendation: Support

Would remove sunset on College and Career Access Pathways (CCAP) partnerships, making the program permanent.

AB 103 (Holden): Dual Enrollment

Board Legislative Principle: State and Federal Partnerships Staff Recommendation: Support Would allow county offices of education to participate in CCAP partnerships.

AB 275 (Medina): Classified Employees

Staff Recommendation: Monitor

AB 288 (Bonta): Student Financial Aid

Staff Recommendation: Monitor

This bill would ensure that private scholarships supplement, and do not supplant, gift aid, grants, scholarships, tuition waivers, and fellowship stipends provided by institutions of higher education to California students who have financial need.

AB 289 (Calderon): Classified School Employee Elections

Staff Recommendation: Monitor

This bill would mandate additional ballot secrecy in the voting process for the adoption or termination of a merit system for classified employees of a community college district; and would further prohibit a representative of the district from marking the ballot or envelope of any employee.

AB 295 (Jones-Sawyer): Work Group to Examine Tuition and Fees

Staff Recommendation: Monitor

This bill would establish a working group consisting of representatives from the State Department of Education, the Board of Governors of the California Community Colleges, the Trustees of the California State University, and the Regents of the University of California to consider the creation of a pilot program that would provide free postsecondary education in the state by replacing the system of charging students tuition and fees for enrollment at a public postsecondary institution. The bill would also require the working group to submit a report to the Legislature on the pilot program.

SB 40 (Hurtado): Health Care Pipeline

Staff Recommendation: Monitor

Would create the California Medicine Scholars Program, a 5-year pilot program commencing January 1, 2023, and would require the Office of Statewide Health Planning and Development to establish and facilitate the pilot program. The bill would require the pilot program to establish a regional pipeline program for community college students to pursue premedical training and enter medical school.

SB 45 (Portantino): Funding for Fire Training Programs

Board Legislative Principle: Increased Public Investment in Student Success Staff Recommendation: Support

SB 228 (Leyva): Foster Youth

Board Legislative Principle: Equity

Staff Recommendation: Support

This bill would change the eligibility criteria for the NextUp program to allow students in foster care after the age of 13 to participate and be eligible for priority registration. This bill also allows colleges to use funds on enrolled NextUp students before their first day of class and allows colleges to prioritize students with lower incomes.

Federal Update

Overview: President Biden has taken the following executive actions that may be relevant to community college students. These actions are consistent with SBCCD's Board Legislative Principle on Equity.

- <u>Proclamation</u> to eliminate the Trump administration's ban on people from several majority Muslim countries entering the United States.
- <u>Memorandum</u> to direct the Homeland Security secretary, in consultation with the attorney general, to take actions preserving the DACA program.
- <u>Executive order</u> to revoke the Trump administration's 2018 executive order to exclude undocumented immigration from the U.S. census.
- <u>Executive order</u> to revoke President Trump's 2017 executive order that made all undocumented immigrants a priority for arrest by Immigration and Customs Enforcement.

(H.R.6) American Dream and Promise Act

Board Legislative Policy: Equity

Staff Recommendation: Support

President Biden put forward a bill proposal to immediately grant temporary residency to those protected by DACA and those who are protected by Temporary Protected Status (TPS), and provide a pathway for citizenship for undocumented individuals by decreasing the amount of time required from 13 years to 8 years by making the naturalization process more efficient. Representative Linda Sanchez (D-CA) and Senator Bob Menendez (D-NJ) will carry the legislation reflecting Biden's proposal.

Hispanic Serving Institutions (HSI) Capital Financing Program

Board Legislative Policy: Increased Public Investment in Student Success Staff Recommendation: Support

The Hispanic Association of Colleges and Universities (HACU) has announced a legislative request to amend the Higher Education Act to create an HSI Capital Financing Program, comparable to that of Historically Black Colleges and Universities (HBCUs). HACU is advocating for \$10 billion in secured loans and accrued interest to support additional classroom facilities, labs, and other infrastructure needed at Hispanic-Serving Institutions.

HSIs are highly diverse institutions that face significant funding limitations. Although HSIs enroll two-thirds of today's 3.8 million Hispanic college students, they also enroll more African Americans than all the HBCUs combined, more American Indians than all the Tribal Colleges and Universities together, and over 40% of all Asian Americans enrolled in college today. Yet, HSIs remain dramatically underfunded. HACU believes that a new program to support the capital financing of the approximately 550 HSIs is essential to increase their capacity to serve the educational needs of their diverse and needy student populations.
