As a matter of law, members of the committee may not discuss or take action on matters raised during public comment unless the matters are properly noticed for discussion or action. #### A. 2021-04-08 BLC Minutes

Trustee Anne Viricel moved to approve the 2021-04-08 BLC minutes. Trustee Frank Reyes seconded the motion.

#### IV. CURRENT ISSUES UPDATE

#### A. State Budget Update Presentation – Mark MacDonald, MGI Advocacy, Inc.

Mr. MacDonald reviewed the legislative timeline.

- May Revise introduced around May 15<sup>th</sup>
- House of Origin Deadline June 4<sup>th</sup>
- Final Budget Floor Vote June 15th
- Policy Committee Deadline July 14th
- Summer Recess July 16th through August 16th
- Fiscal Deadline August 27th

The May revise was reviewed and the analysis of the SBCCD Budget Priorities.

- Administration pegs budget surplus at over \$70 billion. LAO estimates at \$38 billion – LAO does not count mandatory spending.
- Additional Proposition 98 spending of approximately \$17.7 billion.
- \$3.6 billion for community colleges.
- \$24.4 billion in reserves, including \$4.6 billion in School Stabilization Fund.

Mr. MacDonald will send the CalPERS and CalSTRS funding rates to SBCCD when released. SBCCD conducts 5-year forecasting and the CalPERS and CalSTRS funding rates assist in the forecasting. There was discussion regarding the CalSTRS Board and based on a projection of retirements in 2022 the actuarial valuation could be affected. President Rodriguez reported every year the campuses are constantly working on the enrollment management plan and it's a comprehensive plan that includes communications in the classroom and the Community. SBVC has created an advisory committee within the Latino community and the African American community to assist in targeting that specific population of students. Those that influence those students help us increase our enrollment. Through those efforts over the last five months or so SBVC have been able to close the student gap headcount. They have shifted their social media influence to able a strong target audience (students and influencers of those students). The currently proposed State budget is flexible to fit each campus's individual strategies.

Trustee Harrison discussed increasing advocacy for student grants and not student loans. Interim Chancellor Torres reported of Cal Grant Reform that will make more

students eligible to receive financial aid. In addition, one-time federal funding that allows a portion to be given to students.

- M. MacDonald reported the bills of interest:
  - AB 927 (Medina) CCC BA Degree
    - Trustee Longville is interest in utilizing KVCR in creating a bachelor's program which no other institution has the capability of developing. M. MacDonald reported we would have to show the labor market demand, the ability to meet the local needs of the community, submit the application, and approval by the State Chancellor's Office. The Bill was voted 79 0 on the Assembly floor. It will go to Senate in a couple weeks. Trustee Longville expressed this is a very potentially desirable opportunity for SBCCD and we should have a strong interest in pursuing the potential. If the bill is passed, Trustee Harrison suggested both Academic Senates are included in the opportunities available, communication, and collaboration through the entire process.
  - AB 14 (Aguiar-Curry) Broadband Expansion
  - AB 1040 (Muratsuchi) Ethnic Studies
  - AB 75 (O'Donnell) & SB 22 (Glazer) Facilities Bonds

#### **B.** State and Federal Advocacy Update

Cal Grant Equity Framework: A. Rodriguez reviewed the Cal Grant Equity Framework. SBCCD has continued advocating as outlined in AB 1456 (Medina, McCarty, Leyva). On June 3, AB 1456 cleared the Assembly on a bipartisan 69-1, and it now moves to the Senate. If approved and funded, AB 1456 will expand financial aid to 280,000 more Californians. Specifically, it would benefit community college adult learners, by removing barriers like age, high school GPA, and time out of high school requirements.

How SBCCD is helping build public support:

- Briefed Growing Inland Achievement President & CEO Dr. Carlos Ayala of the goals of the Cal Grant Equity Framework and secured GIA's endorsement of AB 1456.
- Invited California Student Aid Commission Executive Director Marlene Garcia for a radio interview on KVCR's "Inland Edition" to discuss financial aid opportunities and AB 1456.
- Earned 8,383 views with SBCCD's Tweet "Let's build a better financial aid system for CA families and students! #CalGrantEquity #AB1456."
- Joined the CCC Chancellor's Office in the June 4 coalition letter to urge the Governor, Senate and Assembly leaders to fund and adopt AB 1456. (Copy enclosed).

A. Rodriguez provided the legislation that SBCCD has been tracking around basic needs, financially aid reform, student housing, etc.

A. Rodriguez publicly thanked Senator Feinstein who is reviewing our federal funding request a 3 million for the craft and fire academy and Senator Padilla is reviewing our request for 3 million for the tech building at SBVC.

The California Community Colleges' Budget and Legislative Request furthers the *Vision for Success* by proposing budget adjustments and policy changes necessary to support our students' success and the state's future. The Request framework is designed to emphasize the need for continuous review of existing laws and policies to determine whether they are advancing—or constraining—colleges' ability to achieve the Vision. This is why we seek your input.

# System Budget and Legislative Request Process

Attached please find the **2022-23 System Budget and Legislative Request Form**. The form provides an opportunity for external organizations to submit a budget or legislative proposal for the Chancellor's Office to consider in budget and legislative advocacy efforts in 2022-23. The Chancellor's Office will make determinations regarding items included in the 2022-23 Budget and Legislative Request. Proposals will be reviewed and assessed by members of the Consultation Council. The final version will be presented to the Board of Governors for consideration and approval.

# Timeline

- June 17: Consultation Council reviews process and timeline.
- July 12-13: Overview of the process is presented to the Board of Governors.
- July 16: Deadline for Submissions. All proposals are due to the Chancellor's Office by 5:00PM.
- July 16-July 30: Proposals are reviewed by the Chancellor's Office.
- August 13: Systemwide Policy Advocacy webinar provides summary of next steps.
- August 19: Review and discuss 2022-23 Shared Advocacy Request with Consultation Council members.
- September 20-21: 2022-23 Shared Advocacy Request is presented for Board of Governors approval.
- September 30: 2022-23 Budget and Legislative Request submitted to the Department of Finance.
