## IV. ADVOCACY UPDATE

#### A. Update on State Legislative of Interest to SBCCD – Angel Rodriguez

A. Rodriguez reviewed the state legislative of interest of SBCCD.

AB 75 is not moving forward this year.

AB 417 is at the Senate and is expected to go to governor 9/10/21

AB 469 has been amended so that schools get support from the state.

AB 775 no longer an active bill. However, the Governor did approve funding for basic need/centers on campus.

AB 927 Community College Baccalaureate Degree opens to all community colleges. Only one campus within the same district can only apply during the same application period. Application periods occur every six months.

- A. Rodriguez to look into if one campus can apply multiple times within the same application period. Also, if multiple campuses can offer the same programs or if each program has to be different.

AB 940 bill died. But still got funded

AB 1106 became a tiered bill.

AB 1111 bill has been funded to create a pilot program.

AB 1185 at the Senate and expected to move to Governor.

AB 1326 at the Senate

AB 1456 Unanimous vote by Senate. Moving to Governor.

AB 1377 No longer moving forward. Executive Vice Chancellor Torres reported a trailered bill supports half the funds will go to community college districts. \$250 million for community college districts. \$225 million for districts to explore affordable student housing. Application deadline is October 31, 2021 and construction must begin by December 2022.

SB 22 no longer moving forward

SB 45 no longer moving forward

SB 228 no longer moving forward

Trustee Longville requested to contact Senator Portantino to keep supporting SB 45: Funding for Fire Training Programs. Also, to work with Senator Leyva to keep supporting SB 228: Foster Youth.

# San Bernardino Community College District Board Legislative Committee December 10, 2021

Item: Update on SBCCD's 2021 Advocacy Efforts

### **Summary:**

This item provides an executive summary of key actions the SBCCD Chancellor's Office has taken recently to engage with policymakers and diverse stakeholders to advocate for public policy solutions that support student achievement and economic mobility in the Inland Empire.

For background, October 9 marked the end of the first year of the 2021-22 Legislative Session. Of the 2,400 bills collectively introduced by the Assembly and Senate, 203 bills had a direct impact to the California Community Colleges. Governor Newsom signed 91 bills into law related to community colleges. The CCC Chancellor's Office has created a report summarizing relevant legislation.

The purpose of the meeting is to strategize federal advocacy to fund facility improvements at Hispanic-Serving Institutions like SBCCD. Date of convening: First quarter of 2022.

# College Affordability & Student Basic Needs

The SBCCD Board of Trustees supports legislation and other reforms to make college more affordable, and measures to address student basic needs.

- Advocated for, and Governor approved ongoing funding that expands financial aid eligibility for 100,000 more community college adult learners (regardless of age or time out of high school) to receive a \$1,650 Cal Grant award to help cover educational and living expenses.
- Advocated for, and pursuing state funding to conduct a feasibility study to build affordable student housing.
   SBCCD is requesting \$970K for CHC and \$1.7M for SBVC. State will announce grant awards by March 2022.
- Chancellor partnered with local K-12 schools, California Student Aid Commission, and state legislators (Connie Leyva, Jose Medina, Rosilicie Ochoa Bogh, and Eloise Gomez Reyes) to host "Cash For College" webinars to encourage FAFSA/California Dream Act Application completion. Next workshop will be held in with Asm. James Ramos in January 2022.

#### **Local Decision-Making**

The SBCCD Board of Trustees affirms its responsibility to make decisions in the best interests of the local community, district, and campuses.

- Collaborating with Redistricting Partners, a consulting firm hired by SBCCD, to provide technical assistance on the district's redistricting process to redraw trustee voter maps based on 2020 U.S. Census population changes. Draft voter maps will be reviewed by the board and public at the Dec. board meeting.
- Established new connection with Inland Empire
  Health Plan (IEHP) that could yield grant funding and
  resources from IEHP to support SBCCD's educational
  campaign to promote COVID-19 vaccine safety and
  efficacy among students, faculty and staff.

# State and Federal Partnerships

The SBCCD Board of Trustees will advocate for legislation where state or federal intervention is justified.

 Planning a special gathering to convey appreciation to Assembly Majority Leader Eloise Gomez Reyes, Assemblymembers James Ramos and Freddie Rodriguez for their leadership securing \$4 million in the 2021-22 state budget to support KVCR TV/FM. Event details are forthcoming.

# **Civic Engagement**

The SBCCD Board of Trustees will advocate for adequate representation of the Inland Empire on legislatively-formed boards, commissions, task forces, study groups, and other bodies that may have an impact on SBCCD's educational mission.

- Pursuing a grant through the Governor's California Volunteers Commission to provide CHC and SBVC students \$10,000 grants for community service.
- Teaming up with the Governor's Office and UC Riverside to co-host a public webinar to educate Inland Empire students and residents on how to get appointed by the Governor to serve on a state board or commission. # San Bernardino Community College District Board Legislative Committee December 10, 2021

Item: 2022 Legislative & Budget Priorities (Draft: First Read)

#### **Summary:**

This item presents the San Bernardino Community College District's legislative and budget priorities for fiscal year 2022-23. The proposal describes the funding and public policies needed for SBCCD to make higher education more accessible and equitable at a time when the Inland Empire continues to grapple with the socioeconomic impacts caused by the COVID-19 global pandemic.

#### Recommendation:

The Board Legislative Committee may make a recommendation to the full SBCCD Board of Trustees to approve SBCCD's 2022 Legislative & Budget Advocacy Priorities at the January 2022 meeting.

# **Board Legislative Principles**

# **Equity**

The SBCCD Board of Trustees supports public policies that increase student success, including completion, transfer, and employment while closing equity gaps and nurturing an anti-racist educational environment.

# Increased Public Investment in Student Success

The SBCCD Board of Trustees supports advocacy to increase state and federal funding, resources, and legislation that strengthen our colleges' ability to meet student equity and workforce development goals.

# SBCCD 2022 Legislative & Budget Advocacy Priorities

- Increase Student Enrollment & Retention: SBCCD supports ongoing funding for enrollment and retention efforts for districts and colleges experiencing steep declines in enrollment, particularly among ethnically diverse and underserved student populations. Funding would support local outreach and marketing strategies.
- Support Faculty Diversity Hiring: SBCCD supports ongoing funding to connect future hiring practices and procedures to statewide equity and diversity efforts.
- Strengthen KVCR TV/FM Educational Media:
   SBCCD requests ongoing state investment to
   strengthen KVCR TV/FM's long-term capacity to serve
   the Inland Empire with PBS and NPR educational
   content, local news, and cultural programming, and
   grow in-studio training opportunities for students
   preparing for media industry careers.
- Increase Base Funding: SBCCD supports \$500 million in ongoing funding to support the educational mission and operations of all California community colleges.
- Address Student Centered Funding Formula: SBCCD supports the extension of the hold-harmless provisions of the SCFF.

- Update Technology Infrastructure: SBCCD supports ongoing funding to ensure students have access to adequate distance learning services, modernize technology infrastructure, and protect sensitive data.
- Provide CalSTRS/CalPERS Relief: SBCCD supports ongoing funding in non-Proposition 98 resources to "buy down" the employer contribution levels required by colleges/districts. Doing so will free up general fund revenues for other student-centered priorities.
- Modernize Facilities & Instructional Equipment: SBCCD supports \$150 million in one-time funding, systemwide, to repair and update campus facilities and educational equipment.

# College Affordability & Student Basic Needs

The SBCCD Board of Trustees supports legislation and other reforms to make college more affordable, and measures to address student basic needs.

- Support Affordable Student Housing: SBCCD supports investments to build student residential housing for community college students experiencing housing insecurity. SBCCD supports ongoing funding to support colleges working with local, county, and student agencies to establish housing options for community college students. Resources are needed to support initial planning, modernization, restoration, and construction.
- Expand Textbook Affordability: SBCCD launched the Books+ program to provide all students with free rental access to textbooks and course materials, limited to the 2021-22 academic year. SBCCD is committed to advancing strategies that make textbooks more affordable to students and ensure they have ongoing access to learning materials on day one.
- Address Student Basic Needs: SBCCD supports ongoing funding to address students' basic needs and provide CalFresh enrollment support, food pantries, and other essential services.
- Reform Cal Grant: SBCCD supports the California Student Aid Commission-sponsored legislation to reform the Cal Grant to provide greater financial aid resources to community college students. Specifically, SBCCD supports reforms that would simplify financial aid and create a Cal Grant 2 for community college students.
