



Budget Gaps






Budget COLA

- The budget uses about \$486 million of one-time funds to support ongoing apportionment costs for the 2024-25 fiscal year.
- This means that approximately 5% of total ongoing apportionments are being funded through one-time funding creating a structural deficit that will need to be filled with the 2025-26 fiscal year.
- This \$486 million shortfall will need to be the first priority for budgets going forward.

2024/25 Budget



How to Solve Problem

- \$13.1 billion from reserves
- \$8.5 billion in reductions
- \$5.7 billion in internal borrowing
- \$5.1 billion in delays
- \$3.4 billion in fund shifts
- \$2.1 billion in deferrals

Proposition 98

- Biggest difference in the Administration's proposed solution and that of the LAO is Proposition 98.
- Administration proposes reduction of \$8 billion to Proposition 98 (\$910 million attributed to CCCs) for the 2022-23 fiscal year.
- DOF has indicated that it will not impact district budgets. Trailer bill will be released sometime this
 month.

California CCs

- ➤ Increase of \$69.1 million for a 0.76% COLA to the Student Centered Funding Formula apportionments.
- Increase of \$29.6 million for 0.5% Growth.
- ➤ Increase of \$9.3 million for a 0.76% COLA for certain categorial programs and Adult Education programs.
- ➤ Withdrawal of \$235.9 million in 2023-24 and \$486.2 million in 2024-25 from the K-14 Rainy Day Fund to support the SCFF.

Increase of \$60 million to expand nursing programs and Bachelor of Science in Nursing partnerships to develop, educate, and maintain the next generation of registered nurses through the community college system, subject to future statutory changes.

CSAC

- The Administration's Budget does not propose "pulling the trigger" on the new Cal Grant Equity Framework implementation.
- The Administration's Budget proposes to wait until the May Revision to see if there are sufficient revenues to implement the changes.

Affordable Student Housing

- SB 117, the Higher Education Trailer bill, shifted the funding source for all affordable student housing projects from state grant dollars to a state-issued lease revenue bond.
- The Administration has indicated that they are working on this plan and will issue the bond in September. No indication that they will cover additional projects.



Legislative Update





SUPPORTED LEGISLATION

AB 247 (Muratsuchi, Fong & Wilson)

Summary: Places a statewide K-14 educational facilities bond on a 2024 statewide ballot providing \$14 billion to K-12 schools and community colleges for building and repairing educational facilities.

Status: Introduced

Alignment with goals: Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

AB 3015 (Ramos)

Summary: Provides residency to students from neighboring Indian tribes. **Status:** 2/17/24 - From printer. May be heard in Committee on March 18.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

AB 2033 (Reyes)

Summary: Requires community colleges to have at least one convenience or grocery store on campus that accepts Electronic Benefit Transfer (EBT) cards as an authorized retail food store under CalFresh, by September 1, 2025.

Status: Assembly Higher Education Committee









SUPPORTED LEGISLATION

AB 1891 (Weber)

Summary: This bill would permit California Community Colleges (CCC) Allied Health programs to utilize multicriteria screening in their admissions processes.

Status: 2/28/24 - Re-referred to Committee on Higher Education

Alignment with goals: Goal 2: Be a Diverse, Equitable, Inclusive & Anti-Racist Institution; CHC Strategic Direction 2: Engage in Practices that Prioritize and Promote Inclusivity, Equity, Anti-Racism, and Human Sustainability; and SBVC Strategic Direction 6: Create and Sustain a Sense of Belonging for all College and Community Stakeholders

Sponsor: CA Community Colleges Chancellor's Office

AB 1885 (Addis)

Summary: This bill would make qualifying for the Student Success Completion Grant (SSCG) more equitable by requiring participating community colleges to also consider awarding a grant to eligible students who enroll in 9 or more units per semester, or the quarterly equivalent, who are considered full-time as part of a disabled student programs and services Academic Accommodation Plan.

Status: 2/5/24 - Referred to Committee on Higher Education.

Alignment with goals: Goal 2, CHC Strategic Direction 2, and SBVC Strategic Direction 6

Sponsor: CA Community Colleges Chancellor's Office







SUPPORTED LEGISLATION

AB 359 (Holden)

Summary: Makes changes to CCAP to align with other dual enrollment programs and removes barriers to students seeking dual enrollment.

Status: 1/29/24 - Referred to Assembly Rules Committee.

Alignment with goals: Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

AB 1796 (Alanis)

Summary: Requires high schools to notify parents of dual enrollment programs that are available.

Status: 1/16/24 - Referred to Assembly Committee on Education.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

AB 2500 (M. Fong)

Summary: Provides CSAC with flexibility to adjust Cal Grant deadlines. **Status:** 2/14/24 - From printer. May be heard in Committee on March 15.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

Sponsor: CA Student Aid Commission









OTHER PRIORITY TRACKED LEGISLATION - UNDER REVIEW

AB 1818 (Jackson)

Summary: This bill would require each campus of the California State University and the California Community Colleges, and would request the University of California, to allow overnight parking by a student attending its campus if the student uses the vehicle as housing, the student has a valid parking permit issued by the campus, and the vehicle is parked in or on a campus-owned and controlled parking lot or parking structure.

Status: 1/22/24 - Referred to Committee on Higher Education.

AB 2093 (Santiago)

Summary: This bill would extend the term of eligibility of the California College Promise Grant for an additional 2 academic years for first-time community college students and returning community college students who matriculate into upper division coursework of a community college baccalaureate degree program. The bill also would add to the funding formula, for funding appropriated for the program in excess of the funding needed to waive all student fees, the number of students who matriculate into upper division coursework of a community college baccalaureate degree program.

Status: 2/20/24 - Referred to Committee on Higher Education.

Alignment with goals: Goal 4: Ensure Fiscal Accountability/Sustainability; CHC Strategic Direction 5: Foster and Support Inquiry, Accountability, and Campus Sustainability; and SBVC Strategic Direction 8: Ensure Sustainability Through Fiscal Accountability







OTHER PRIORITY TRACKED LEGISLATION – UNDER REVIEW

AB 2015 (Schiavo)

Summary: Requires nursing faculty to have an active license in good standing. **Status:** 2/12/24 - Referred to Assembly Committee on Business and Professions.

Alignment with goals: Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

AB 2104 (Soria) & SB 895 (Roth)

Summary: Authorizes CCCs to offer BSNs on a pilot basis.

Status: 2/20/24 - Referred to Assembly Committee on Higher Education.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

AB 2567 (Mathis) & SB 1183 (Hurtado)

Summary: Adds "residing in a medically underserved area" to MCS criteria.

Status: 3/4/24 - Referred to Assembly Committee on Higher Education.







OTHER PRIORITY TRACKED LEGISLATION – UNDER REVIEW

SB 1015 (Cortese)

Summary: Creates a study on clinical placements.

Status: 2/14/24 - Referred to Assembly Committee on Business and Professions and Assembly Committee on Education.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

SB 1042 (Roth)

Summary: Requires greater health facilities and nursing schools.

Status: 2/14/24 - Referred to Senate Committee on Health.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

SB 1244 (Newman)

Summary: Allows a community to enter into a CCAP agreement with a high school outside its service area.

Status: 2/29/24 - Referred to Senate Committee on Education.







OTHER PRIORITY TRACKED LEGISLATION – UNDER REVIEW

AB 2093 (Santiago)

Summary: Expands College Promise eligibility to CCC baccalaureate students.

Status: 3/6/24 - Referred to Assembly Committee on Higher Education.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

AB 2458 (Berman)

Summary: Requires colleges to provide COA information to student parents. **Status:** 2/26/24 - Referred to Assembly Committee on Higher Education.



AB 2588 (Chen)

Summary: Requires Department of Education to evaluate the effectiveness of college acceleration programs including dual enrollment.

Status: 3/4/24 - Referred to Assembly Education Committee.







OTHER PRIORITY TRACKED LEGISLATION – UNDER REVIEW

AB 3240 (Calderon)

Summary: Prohibits scholarship displacement for Cal Grant awards. **Status:** 3/17/24 - From printer. May be heard in Committee on March 18.

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

SB 971 (Portantino)

Summary: Exempts students impacted by war from nonresident tuition.

Status: 2/14/24 - Referred to Committee on Higher Education. Set for hearing March 12. **Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

AB 2019 (V. Fong)

Summary: Exempts a pupil from the 240 instructional minute minimum school day if they are in a dual enrollment program.

Status: 2/12/24 - Referred to Assembly Committee on Education.
