## IV. CURRENT BUSINESS

### A. Updates

#### a. Regional, State, and Federal Grants Update

- i. \$11.2 million in grants this year.
- ii. This year, we have submitted grant proposals for a total of \$16,377,466.33.
- iii. Thus far, we've won 14 grants totaling about \$11.5 million and await results from others.
- iv. This proactive approach is crucial for bridging funding gaps and fostering growth and innovation across our district.
- v. These grants align with SBCCD's strategic directions and college educational master plans.

#### b. Legislative Updates

- i. Budget Update: The Assembly/Senate and Administration will continue to meet over the next few weeks to hammer out an agreement. Full update next week.
- ii. Bond Debate: Currently, there is a debate in the Legislature as to which bonds will go before the voters in November.

### **AB 247 (Muratsuchi, Fong & Wilson)**

**Summary:** Places a statewide K-14 educational facilities bond on a 2024 statewide ballot providing \$14 billion to K-12 schools and community colleges for building and repairing educational facilities.

**Status:** The decision to go the ballot must be made by June 27th.

**Alignment with goals:** Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

### **AB 3015 (Ramos)**

**Summary:** Provides residency to students from neighboring Indian tribes.

**Status:** 6/5/24 - Referred to Education Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

### **AB 2033 (Reyes)**

**Summary:** Requires community colleges to have at least one convenience or grocery store on campus that accepts Electronic Benefit Transfer (EBT) cards as an authorized retail food store under CalFresh, by September 1, 2025.

**Status:** 6/5/24 - Referred to Human Services Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

### **AB 1891 (Weber)**

**Summary:** This bill would permit California Community Colleges (CCC) Allied Health programs to utilize multicriteria screening in their admissions processes.

**Status:** 5/29/24 - Referred to Appropriations Committee

**Alignment with goals:** Goal 2: Be a Diverse, Equitable, Inclusive & Anti-Racist Institution; CHC Strategic Direction 2: Engage in Practices that Prioritize and Promote Inclusivity, Equity, Anti-Racism, and Human Sustainability; and SBVC Strategic Direction 6: Create and Sustain a Sense of Belonging for all College and Community Stakeholders

**Sponsor:** CA Community Colleges Chancellor's Office

### **AB 1885 (Addis)**

**Summary:** This bill would make qualifying for the Student Success Completion Grant (SSCG) more equitable by requiring participating community colleges to also consider awarding a grant to eligible students who enroll in 9 or more units per semester, or the quarterly equivalent, who are considered full-time as part of a disabled student programs and services Academic Accommodation Plan.

**Status:** 5/29/24 - Referred to Committees on Education and Appropriations

**Alignment with goals:** Goal 2, CHC Strategic Direction 2, and SBVC Strategic Direction 6

**Sponsor:** CA Community Colleges Chancellor's Office

**AB 359 (Holden)**

**Summary:** Makes changes to College and Career Access Pathways to align with other dual enrollment programs and removes barriers to students seeking dual enrollment.

**Status:** 5/24/24 - In Senate Education Committee

**Alignment with goals:** Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

**AB 1796 (Alanis)**

**Summary:** Requires high schools to notify parents of dual enrollment programs that are available.

**Status:** 5/29/24 - Referred to Senate Appropriations Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**AB 2500 (M. Fong)**

**Summary:** Provides California Student Aid Commission with flexibility to adjust Cal Grant deadlines.

**Status:** 5/29/24 - Referred to Education Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**Sponsor:** CA Student Aid Commission

**AB 2104 (Soria)**

**Summary:** Authorizes CCCs to offer BSNs on a pilot basis.

**Status:** 6/5/24 - Referred to Senate Education Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 895 (Roth)**

**Summary:** Authorizes CCCs to offer BSNs on a pilot basis.

**Status:** 5/28/24 - Referred to Assembly Higher Education Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

## OTHER PRIORITY TRACKED LEGISLATION – UNDER REVIEW

**AB 2093 (Santiago)**

**Summary:** This bill would extend the term of eligibility of the California College Promise Grant for an additional 2 academic years for first-time community college students and returning community college students who matriculate into upper division coursework of a community college baccalaureate degree program. The bill also would add to the funding formula, for funding appropriated for the program in excess of the funding needed to waive all student fees, the number of students who matriculate into upper division coursework of a community college baccalaureate degree program.

**AB 2015 (Schiavo)**

**Summary:** Requires nursing faculty to have an active license in good standing.

**Status:** 5/29/24 - Referred to Senate Business, Professions and Economic Development Committee

**Alignment with goals:** Goal 1: Eliminate Barriers to Student Access and Success; CHC Strategic Direction 1: Increase Student Enrollment; and SBVC Strategic Direction 1: Create a College-Going Culture Through Intentional Community Outreach and Clear Communication of Pathways

**AB 2567 (Mathis)**

**Summary:** This bill expands the information related to campus-owned, campus-operated, or campus-affiliated student housing that California State University (CSU) and the California Community Colleges (CCCs) are required, and University of California (UC) is requested, to post online to also include specified information about veterans.

**Status:** 6/5/24 - Referred to Senate Military and Veterans Affairs Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 1183 (Hurtado)**

**Summary:** This bill adds living in a medically underserved area or population as a factor for consideration in the multicriteria screening tool used for admission into an impacted registered nursing program at a California Community College (CCC).

**Status:** 4/24/24 - Referred to Committee on Higher Education

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 1015 (Cortese)**

**Summary:** Creates a study on clinical placements.

**Status:** 6/3/24 - Referred to Committee on Business and Professions

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**AB 2019 (V. Fong)**

**Summary:** Exempts a pupil from the 240 instructional minute minimum school day if they are in a dual enrollment program.

**Status:** 6/5/24 - Referred to Senate Education Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 1042 (Roth)**

**Summary:** Requires health facilities and clinics to report data related to the availability of clinical placements for nursing students to the Department of Health Care Access and Information, and requires nursing schools to report data related to their clinical placement needs to the Board of Registered Nursing.

**Status:** 6/3/24 - Referred to Assembly Health and Business and Professions Committees

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 1244 (Newman)**

**Summary:** Allows a community to enter into a CCAP agreement with a high school outside its service area.

**Status:** 6/3/24 - Referred to Assembly Higher Education and Education Committees

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**AB 2458 (Berman)**

**Summary:** Establishes the Greater Accessibility, Information, Notice, and Support (GAINS) for Student Parents Act; requiring each campus of the California Community Colleges (CCC) and the California State University (CSU), and requesting each campus of the University of California (UC), to, in part, 1) develop and implement a campus policy for estimating and adjusting cost of attendance information for student parents.

**Status:** 5/29/24 - Referred to Senate Education Committee

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**AB 2588 (Chen)**

**Summary:** Requires Department of Education to evaluate the effectiveness of college acceleration programs including dual enrollment.

**Status:** 5/16/24 - Held in Appropriations Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**AB 3240 (Calderon)**

**Summary:** Prohibits scholarship displacement for Cal Grant awards.

**Status:** 5/29/24 - In Senate Education Committee

Alignment with goals: Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 971 (Portantino)**

**Summary:** Exempts students impacted by war from nonresident tuition.

**Status:** 5/28/24 - In Assembly Higher Education Committee

**Alignment with goals:** Goal 1, CHC Strategic Direction 1, and SBVC Strategic Direction 1

**SB 1321 (Wahab)**

**Summary:** This bill includes additional goals and project requirements for the Employment Training Panel (ETP), including meeting Division of Apprenticeship Standards (DAS) criteria for high road job training programs. This bill would also prohibit a proposal from being considered or approved if, among other things, an applicant is ineligible to bid, be awarded, or subcontract on a public works project. Additionally, the bill would require ETP to provide notice of the intent to award proposals at least 30 days before a meeting to approve or reject a proposed award.

## OPPOSED LEGISLATION

**AB 1818 (Jackson)**

**Summary:** Requires the California Community College (CCC) Chancellor's Office and the California State University (CSU)

Chancellor's Office to each establish a pilot program to allow overnight parking on campuses by eligible students

**Status:** 6/5/24 - Referred to Senate Education and Judiciary Committees

**AB 2088 (McCarthy)**

**Summary:** Establishes a statutory right of first refusal to current regular nonprobationary classified employees (CRNCEs) of school and community districts relating to part-time and full-time vacant positions, and requires educational employers to adhere to certain prescribed requirements, among other provisions.

**Status:** 6/5/24 - Referred to Senate Labor, Public Employment and Retirement, Rules, and Appropriations Committees

**SB 1388 (Archuleta)**

**Summary:** This bill establishes an annual 16.7 percent reserve cap for a community college district, unless the district participates in specified employee benefit programs and has at least 75 percent of instruction taught by full-time instructors.

**Status:** 5/16/24 - Held in Appropriations Committee

d. Proposition 98

Accrues e \$6.2 billion of funds previously appropriated to schools and community colleges for 2022-23 over several years beginning in 2026-27—that is, those funds will be accounted for in the General Fund accounting ledgers over several future years, instead of in 2022-23.

-Suspends Proposition 98 in the 2023-24 budget year. With the suspension, over \$8 billion of “maintenance factor” is created to be paid to schools and community colleges in future years.

-Uses of \$8.4 billion from the Proposition 98 reserve to protect K-12 and community college funding despite the proposed suspension.

-The budget package leaves about \$1.1 billion in the Proposition 98 reserve in 2024-25—more than in the May Revision which proposed to spend all of it.

-Defers s \$446.4 million Proposition 98 General Fund associated with apportionments from 2023-24 to 2024-25. -Defers \$246.7 million Proposition 98 General Fund from 2024-25 to 2025-26.

-Uses \$545.9 million Proposition 98 General Fund from the Public School System Stabilization Account to support apportionment costs in 2023-24.

-Uses \$241.8 million Proposition 98 General Fund from the Public School System Stabilization Account to support a repayment of the 2022-23 categorical program deferral in 2023-24.

e. Bills of Interest

- AB 2104 (Soria) –Baccalaureate Degree in nursing.
- SB 895 (Roth) –Baccalaureate Degree in nursing.
- AB 1142 (Fong, Mike) –Coordinating commission for postsecondary education in California –Gut and amended to deal with extension of Civic Center Act.
- AB 1818 (Jackson) –Requires up to 20 CCCs to allow students to park overnight in their cars on their campus.
- AB 247 (Muratsuchi & Fong) –Education Facilities Bond K-14 --\$10 billion bond of which \$1.5 billion will go to community colleges. This measure will appear on the November ballot.
- SB 28 (Glazer) –Education Facilities Bond K-University –dead
- AB 2277 (Wallis) –Increase load for part-time community college faculty to 80%-85% of a full-time load.
- AB 2370 (Cervantes) –Prohibit artificial intelligence from being used to replace community college faculty for purposes of providing academic instruction.

- AB 2093 (Santiago) –Extend Community College Promise Program to community college baccalaureate degree programs.
- AB 3015 (Ramos) –Requires a public institution of higher education to provide resident tuition rates to a student who (1) is a member of a federally recognized Indian tribe in California whose tribal land lies across the state border of California and Arizona, Nevada, or Oregon, and (2) resides in one of the aforementioned bordering states.
- AB 1885 (Addis) –Extend Student Success and Completion Grant to DSPP students that are taking 9 or more units and are considered full-time.
- AB 2033 (Reyes) –Requires CCCs to request authorization for one general on campus store be designated an electronic benefit transfer (EBT) authorized retail food store.
- SB 971 (Portantino) –Exempt from nonresident tuition and fees a resident of a region impacted by war or regional conflict.
- SB 1321 (Wahab) -requires an Employment Training Panel (ETP) project proposal to meet additional minimum standards and prioritizes funding for additional types of projects meeting certain goals.

f. Updates

i. Legislative Updates

**Budget Update:** The Department of Finance released their latest Finance Bulletin, and revenues for the month of May coming in approximately \$2.7 billion above May Revision estimates. This puts revenues above forecasts approximately \$2.8 billion for the fiscal year.

**Bond Debate:** The Legislature and Administration came to an agreement on two bonds that will go before voters in November. One, an Education Facilities Bond, will include \$10 billion in funding for K-12 schools and community colleges. Of the \$10 billion, should the measure pass, community colleges receive approximately \$1.5 billion.

**Nursing Bills:** A deal was reached between the two authors of the nursing bills moving through the Legislature, SB 895 (Roth) and AB 2104 (Soria). Under the agreement, two districts in Assemblymember Soria’s district will have statutory priority, but the 15-district limit will move forward in Senator Roth’s bill.

## ***Sample Community College Board of Trustees Resolution***

### **Proposition 2: Kindergarten Through Grade 12 Schools and Local Community College Public Education Facilities, Modernization, Repair, and Safety Bond Act of 2024**

WHEREAS, the California Community College system is the largest postsecondary system of education in the world, enrolling approximately 2 million students each year; and

WHEREAS, California's 116 community colleges and 72 centers are located in nearly every community in the state, serving more than 70 percent of California's public postsecondary undergraduate students; and

WHEREAS, the primary mission of the California Community Colleges is to offer academic and vocational instruction, by granting certificates, associate degrees, and select Baccalaureate degrees, and providing transfer opportunities to four-year institutions; and

WHEREAS, the California Community College Chancellor's Office estimates unmet community college facilities needs of approximately \$27.5 billion over the next five years; and

WHEREAS, Proposition 2, the Kindergarten Through Grade 12 Schools and Local Community College Public Education Facilities, Modernization, Repair, and Safety Bond Act of 2024, provides \$1.5 billion to community colleges for constructing new classrooms to accommodate growth and provide job training, repairing health and safety issues, renovating facilities, and equipping learning spaces with essential technology; and

WHEREAS, facilities support student success and basic needs of our students, providing spaces to access important services like food, health care, counseling, and financial aid; and

WHEREAS, 13,000 middle class jobs, including almost all building trades, are created for each \$1 billion in school facility infrastructure investments; and

WHEREAS, quality community college facilities enhance the education and training of a skilled 21<sup>st</sup> Century workforce, in furtherance of the State's academic and economic goals; and

WHEREAS, Proposition 2 will not raise State taxes, and state matching funds reduce the need for additional local property taxes for college facilities.

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the San Bernardino Community College District supports Proposition 2, *the Kindergarten Through Grade 12*

*Schools and Local Community College Public Education Facilities Modernization, Repair, and Safety Bond Act of 2024.*

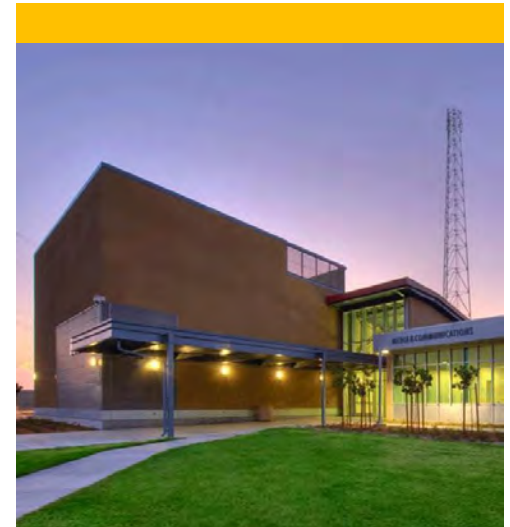
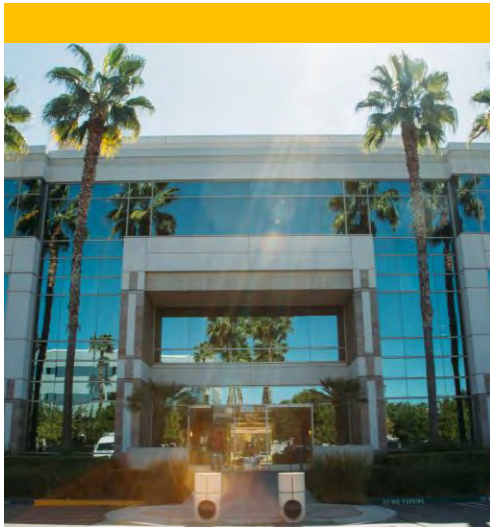

# Top Sacramento Updates

---

- **End of Session:** The Governor vetoed both AB 2104 (Soria) and SB 895 (Roth). These bills would have authorized a minimum number of community college districts to offer baccalaureate degrees in nursing. In addition, he vetoed AB 2093 (Santiago) which would have authorized community colleges to extend their promise programs to community college baccalaureate students.
- **Proposition 2 Resolution:** Proposition 2, which would provide for \$10 billion in funding to go toward K-12 school and community college facilities, will appear on the November ballot this year. Of the \$10 billion, \$1.5 billion would go towards community college facilities.
