**BLC Charge:**

#### Enacted Legislation - 2024 Legislative Update

#### **Accountability**

#### AB 2758 (Gallagher R) California Postsecondary Education Commission: annual report.

Location: 5/2/2024-A. DEAD

**Summary:** This is a spot bill that would make nonsubstantive changes to provisions of law relating to the California Postsecondary Education Commission.

#### AB 2936 (Jackson D) Higher Education Reconciliation Act.

Location: 9/28/2024-A. VETOED

**Summary:** This bill would require the California Community Colleges and the California State University, and request the University of California, to develop a reconciliation master plan for use on each of their respective campuses to address cultural and political conflicts that arise on campus. The bill would require the plan to ensure that students have a forum to be seen, have their voices heard, and feel safe.

#### **Allied Health**

#### AB 689 (Carrillo, Wendy D) Community colleges: enrollment and registration: incumbent health care workers.

**Location:** 8/15/2024-S. DEAD

**Summary:** The bill would require a community college with a limited enrollment course or program to ensure that at least 15 percent of the admitted students, but no less than 3 students per incoming cohort, in the course or program are incumbent health care workers. The bill would require a community college that administers a priority enrollment system to grant priority in that system to students who are incumbent health care workers. The bill would define "incumbent health care worker" and "health care facility" for purposes of these provisions. The bill would also extend the provisions of the multi-criteria screening process indefinately.

#### AB 1695 (Gipson D) Career technical education: Nursing Pathway Pilot Program.

Location: 8/31/2024-S. DEAD

**Summary:** This bill would require the Superintendent of Public Instruction, subject to an appropriation of one-time funds for this purpose in the annual Budget Act or another statute, to allocate funding for the development of career pathways toward an associate degree in nursing at any of California's community colleges at schoolsites that serve pupils in grades 9 to 12, inclusive, to be known as the Nursing Pathway Pilot Program. The bill would require the Superintendent to allocate these funds to pilot local educational agencies, as defined to include school districts, county offices of education, state special schools, and charter schools schools, on the basis of an equal amount per unit of average daily attendance, as those numbers were reported at the time of the first principal apportionment for the 2022–23 fiscal year. The bill would require the Superintendent to select those pilot local educational agencies through a competitive application process by no later than July 1, 2024, based on an applicant's demonstrated ability with a community college to meet specified requirements. The bill would require those recipients the selected pilot local educational agencies to expend allocated funds for, among other things, instructional materials aligned to the applicable science curriculum framework adopted by the State Board of Education and addressing the nursing profession.

#### AB 2104 (Soria D) Community colleges: Baccalaureate Degree in Nursing Pilot Program.

Location: 9/27/2024-A. VETOED

**Summary:** This bill would require the Chancellor of the California Community Colleges to develop a Baccalaureate Degree in Nursing Pilot Program that authorizes select community college districts to offer a Bachelor of Science in Nursing degree. The bill would limit the pilot program to 15 community college districts statewide and would require the chancellor to identify eligible community college districts based on specified criteria.

#### AB 2532 (Mathis R) Community colleges: registered nursing programs.

Location: 7/2/2024-S. DEAD

**Summary:** This bill would add being a resident of the community college district to the list of life experiences or special circumstances specified for consideration in a multicriteria screening process. The bill would extend operation of these provisions relating to admission to community college nursing programs until January 1, 2030.

#### **SB 895** (Roth D) Community colleges: Baccalaureate Degree in Nursing Pilot Program.

Location: 9/27/2024-S. VETOED

**Summary:** This bill would require the Chancellor of the California Community Colleges to develop a Baccalaureate Degree in Nursing Pilot Program that authorizes select community college districts to offer a Bachelor of Science in Nursing degree. The bill would limit the pilot program to 15 community college districts statewide and would require the chancellor to identify eligible community college districts based on specified criteria.

#### **Basic Needs**

#### AB 1967 (Jackson D) Food Insecurity Officer.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would create, within the Government Operations Agency, a Food Insecurity Officer, to be appointed by, and serve at the pleasure of, the Governor. The Food Insecurity Officer would be required to report to the Secretary, or the Secretary's designee, of the Government Operations Agency. The bill would require the Food Insecurity Officer to coordinate and address food insecurity throughout state government operations and would authorize the Food Insecurity Officer to engage with state entities for these purposes.

#### AB 2150 (Arambula D) Public social services: higher education.

**Location:** 5/16/2024-A. DEAD

**Summary:** This bill would require a county human services agency to receive input from community college basic needs directors and basic needs coordinators when developing the protocols for engagement between the county human services agency and institutions of public higher education. The bill would require the Department of Social Services, in consultation with staff liaisons and basic needs directors or basic needs coordinators, to develop training on topics related to determining student eligibility for public social services. The bill would require the department to convene a workgroup that includes all 58 county staff liaisons and representatives from the segments of postsecondary education. The bill would require the department, in collaboration with the workgroup, to (1) discuss enrollment trends in public social services programs and (2) identify barriers to enrollment and action to resolve those barriers.

#### **Bonds**

#### (Glazer D) Education finance: school facilities: Public Preschool, K-12, and College Health and Safety Bond Act of 2024.

Location: 8/31/2024-A. DEAD

**Summary:** This bill would set forth the Public Preschool, K–12, and College Health and Safety Bond Act of 2024 as a state general obligation bond act that would provide \$15,500,000,000 to construct and modernize education facilities, as specified. This bond act would become operative only if approved by the voters at the March 5, 2024, statewide primary election. The bill would also provide for the submission of the bond act to the voters at that election.

#### **Brown Act**

#### **AB 1275** (Weber D) Health information.

Location: 8/31/2024-S. DEAD

**Summary:** This bill would authorize the recognized statewide community college student organization and other student-run community college organizations to use teleconferencing for their meetings without having to (1) post agendas at all teleconferencing locations, (2) identify each teleconference location in the notice and agenda, (3) make each teleconference location accessible to the public, and (4) require that a quorum of the student organization's members participate from a singular physical location.

#### **Budget**

#### **AB 101** (Ting D) Budget Act of 2023.

Location: 8/31/2024-S. DEAD

**Summary:** This bill would make appropriations for the support of state government for the 2023–24 fiscal year.

#### AB 1812 (Gabriel D) Budget Act of 2024.

**Location:** 8/31/2024-A. DEAD

Summary: This bill would make appropriations for the support of state government for the 2024–25

fiscal year.

#### SB 917 (Skinner D) Budget Act of 2024.

Location: 8/31/2024-S. DEAD

Summary: This bill would make appropriations for the support of state government for the 2024–25

fiscal year.

#### **SB 1388** (Archuleta D) Education finance: community colleges: general fund balance.

**Location:** 5/16/2024-S. DEAD

**Summary:** This bill would prohibit, commencing with the 2025–26 fiscal year, a community college district's annual unrestricted general fund balance for a fiscal year from exceeding 16.7% of its unrestricted general fund expenditures for that year, unless the community college district meets specified conditions. The bill would prohibit a community college district from transferring unrestricted general funds to another fund if the receiving fund has an existing balance of 33% or more of the community college district's unrestricted general fund expenditures for that fiscal year or if the transfer would cause the receiving fund to have a balance of 33% or more of the community college district's unrestricted general fund expenditures for that fiscal year. For a community college district that violates the above-described prohibitions, the bill would require a community college district to distribute the amount of the annual unrestricted general fund balance that exceeds 16.7% to nonsupervisory and nonmanagement employees of the community college district.

#### **Campus Safety**

#### AB 1818 (Jackson D) Public postsecondary education: overnight student parking: pilot program.

**Location:** 8/15/2024-S. DEAD

**Summary:** This bill would require each campus of the California State University and the California Community Colleges, and would request the University of California, to allow overnight parking by a student attending its campus if the student uses the vehicle as housing, the student has a valid parking permit issued by the campus, and the vehicle is parked in or on a campus-owned and controlled parking lot or parking structure. The bill would additionally prohibit each campus of the California State University and the California Community Colleges from citing or otherwise penalizing, and would request each campus of the University of California to not cite or otherwise penalize, a student attending its campus for using a vehicle as housing.

#### AB 2492 (Irwin D) Public postsecondary education: sex discrimination complaints: advocates and coordinators.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would require, on or before July 1, 2026, a public postsecondary educational institution, defined as any campus of the California Community Colleges, the California State University, or the University of California, in order to comply with the specified provisions of the Equity in Higher Education Act, to establish and designate at least one person to fulfill the positions of confidential student advocate, confidential staff and faculty advocate, and confidential respondent services coordinator to assist students, faculty, or staff who have filed a complaint of sex discrimination, experienced sex discrimination, or are accused of sex discrimination. The bill would require those positions to, among other things, be independent from the Title IX office, receive specified training, and subject to permission from the student, faculty, or staff, provide information about where the student, faculty, or staff can access campus resources.

#### **Career Technical Education**

#### AB 377 (Muratsuchi D) Career technical education: California Career Technical Education Incentive Grant Program: Strong Workforce Program.

**Location:** 8/15/2024-S. DEAD

**Summary:** This bill would, amongst other provisions, as of July 1, 2024, repeal the K–12 component of the Strong Workforce Program and would require the administration of any outstanding allocations for the K–12 component of the Strong Workforce Program to be administered by CDE pursuant to the California Career Technical Education Incentive Grant Program.

#### AB 2273 (Holden D) Career technical education: California Pilot Paid Internship Program.

**Location:** 5/16/2024-A. DEAD

Summary: This bill would establish the California Pilot Paid Internship Program in the department to

help prepare thousands of California pupils for high-skill jobs of the future in engineering, health care, mathematics, manufacturing, science, teaching, and technology.

#### **Concurrent Enrollment**

<u>AB 359</u> (<u>Holden</u> D) Pupil instruction: dual enrollment: College and Career Access Pathways partnerships.

Location: 9/27/2024-A. VETOED

**Summary:** This bill would clarify that College and Career Access Pathways (CCAP) partnerships can offer dual enrollment to all students, prioritizing those not typically college bound or underrepresented in higher education, and authorizes community college districts in CCAP partnerships to offer specific physical education courses. Additionally, the bill would ensure students get credit for specified courses, changes reporting to focus on student success, removes specified consultation requirements, and requires existing CCAP agreements to be updated by 2030-31.

AB 2019 (Hoover R) Early and middle college high schools and programs.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would expand the definition of early and middle college high schools to include early and middle college programs established within a high school. This bill would also exempt a pupil enrolled in an early college program or a middle college program from the 240-minute minimum schoolday if the pupil is also enrolled in a community college, classes of the California State University, or classes of the University of California.

#### **Courses and Programs**

AB 456 (Maienschein D) Public postsecondary education: campus mental health hotlines: report.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would require each campus of the California State University and the California Community Colleges without a campus mental health hotline, and would request the University of California, to establish a campus mental health hotline for students to access mental health services remotely that operates during working hours.

AB 506 (Fong, Mike D) California State University: graduation requirement: ethnic studies.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would delay the requirement for the California State University to require one 3-unit ethnic studies course as an undergraduate graduation requirement by one year to instead commence with students graduating in the 2025–26 academic year. The bill would require the California State University to collaborate with the office of the Chancellor of the California Community Colleges, the Academic Senate of the California State University, the Academic Senate for California Community Colleges, the California Community Colleges Ethnic Studies Faculty Council, and the California State University Council on Ethnic Studies to develop a process for the California State University to approve community college ethnic studies courses, as meeting the requirements of a California State University ethnic studies course provided pursuant to these provisions, for students who transfer to the California State University from California Community Colleges.

AB 1393 (Calderon D) Student Aid Commission: California Dream Act: Food Support Pilot Program.

Location: 8/15/2024-S. DEAD

**Summary:** TThis bill, until July 15, 2029, would require the Student Aid Commission to establish the Food Support Pilot Program for a 4-year period to provide food support grants to qualifying students who submit a California Dream Act application, as specified. The bill would require the commission to allocate the award on a semester or quarterly basis to a qualifying institution, as defined, if certain program eligibility requirements are met and would require a qualifying institution to provide the funds to the student. The bill would, for each year of the program, require an individual award to equal the maximum amount allocated to one CalFresh recipient during that year.

AB 2044 (Chen R) Public postsecondary education: community colleges: statewide baccalaureate degree program.

**Location:** 8/15/2024-S. DEAD

**Summary:** This bill would require the chancellor to evaluate whether baccalaureate degree holders are paid more than associate degree holders in the same field when conducting a review to approve the elimination of an associate degree program.

AB 2152 (McCarty D) California State University: University of California: graduation requirements: service learning pilot program.

Location: 5/16/2024-A. DEAD

Page 25 of 44 **Summary:** This bill would, commencing with the 2026–27 academic year, require each California State

University and University of California State University and University of California campus to provide on its internet website information on service learning programs and opportunities for undergraduate students. The bill, commencing with students graduating in the 2033-34 academic year, would require the California State University and the University of California, for at least 3 campuses each, to adopt a pilot program making the completion of a service learning program a graduation requirement.

#### (Fong, Mike D) Public postsecondary education: community colleges: statewide baccalaureate **AB 2305** degree program.

**Location:** 7/2/2024-S. DEAD

**Summary:** This bill would require that a community college district is provided with one timeline in which to apply for a baccalaureate degree program, with a total of 30 baccalaureate degree programs approved per academic year, and that a minimum of 90 days is taken to validate the submitted information and assess the workforce value of the proposed baccalaureate degree program. This bill would provide that the California State University and the University of California have 105 days after receipt of the proposal to submit written objections with supporting evidence and the chancellor has 90 days after receipt of written objections to convene with the applicant and the segment or segments that raised an objection to collaborate and establish a written agreement before the program is approved.

#### (Jones-Sawyer D) Los Angeles Community College District: California Center for Climate Change **AB 3142** Education.

Location: 9/27/2024-A. VETOED

Summary: This bill would establish the California Mobile Climate Change Education Center, as part of the Los Angeles Community College District, to be located at West Los Angeles College, with a mission to create opportunities for students to engage in hands-on internships and other learning opportunities, as provided. The bill would appropriate \$1.5 million from the General Fund to the district for the development and initial operations of the Mobile Center.

#### **SB 711** (Caballero D) Community colleges: blockchain industry report.

**Location:** 8/15/2024-A. DEAD

Summary: This bill would require the office of the Chancellor of the California Community Colleges to convene, until July 1, 2026, a working group to take certain actions related to blockchain certification and degree programs at community colleges, including identifying key elements of creating a blockchain associate of arts degree program and a blockchain technical certification program and developing training manuals, guidelines, and other materials necessary to duplicate the blockchain degree and certification programs at community colleges statewide.

#### **SB 1122** (Seyarto R) Peace officers: educational requirements.

Location: 8/31/2024-A. DEAD

Summary: This bill would specify that a bachelor's degree required for employment as a peace officer may be obtained after completion of the Peace Officer Standards and Training program and within 36 months of employment as a peace officer.

#### **Employees**

#### **AB 2901** (Aguiar-Curry D) School and community college employees: paid disability and parental leave.

Location: 8/31/2024-S. DEAD

Summary: The bill would require a public school employer to, for a certificated employee or an employee in the classified service of the public school employer, and would require a community college district to, for an academic employee or an employee in the classified service of the community college district, provide up to 14 weeks of a leave of absence with full pay for an employee who is required to be absent from duty because of pregnancy, miscarriage, childbirth, termination of pregnancy, or recovery from those conditions. The bill would authorize the paid leave to begin before and continue after childbirth if the employee is actually disabled by pregnancy, childbirth, termination of pregnancy, or a related condition. The bill would prohibit a leave of absence taken pursuant to these provisions from being deducted from other leaves of absence.

#### **Facilities**

#### **AB 527** (Calderon D) Urban forestry: school greening projects: grants.

Location: 8/15/2024-S. DEAD

Summary: This bill would require funds appropriated or allocated to the department for the bill's purposes to be administered to support school greening, as defined not to include community college districts, by providing grants to eligible local educational agencies, as defined, nonprofit organizations, cities, counties, and districts, including special districts, through a competitive grant process.

#### SB 1023 (Wilk R) California State University: Antelope Valley or Victor Valley campus.

**Location:** 5/16/2024-S. DEAD

**Summary:** This bill would authorize the Chancellor of the California State University to conduct and submit to the trustees a study about the feasibility of a California State University satellite program, and ultimately, an independent California State University campus, in the Antelope Valley or the Victor Valley within 18 months after the date that the trustees certify that sufficient funds are available to conduct the study. The bill would require funding for the study to be derived solely from nonstate sources. If the trustees decide that a new campus or off-campus center is needed in the Antelope Valley or the Victor Valley, the bill would authorize the trustees to conduct a formal study of the proposal.

#### **Faculty**

#### AB 2277 (Wallis R) Community colleges: part-time faculty.

Location: 9/22/2024-A. VETOED

**Summary:** This bill would require community colleges, as a condition of receiving funding allocated for the Student Equity and Achievement Program, to negotiate in good faith with the exclusive representative for part-time, temporary faculty on the terms of the reemployment preference for part-time, temporary faculty assignments and the regular evaluation process for part-time, temporary faculty. The bill would instead require that negotiation on reemployment preference for part-time, temporary faculty assignments be based on the minimum standards up to the range of 80% to 85% of a full-time equivalent load, and would prohibit the community college district from restricting the terms of the negotiated agreement to less than that range, unless explicitly agreed upon by an individual part-time, temporary faculty member and the district.

#### **Fees**

#### AB 1860 (Bauer-Kahan D) Personal Income Tax Law: exclusions: student loan debt.

**Location:** 8/31/2024-A. DEAD

**Summary:** This bill, for taxable years beginning on or after January 1, 2024, and before January 1, 2029, would exclude qualified discharge of indebtedness income from gross income. The bill would define "qualified discharge of indebtedness income" for this purpose to mean income that would otherwise be realized from the discharge of student loan debt or medical debt that is discharged by a qualifying nonprofit organization.

#### AB 2093 (Santiago D) Community colleges: California College Promise: fee waiver eligibility.

Location: 9/22/2024-A. VETOED

**Summary:** This bill would extend the term of eligibility of the California College Promise Grant for an additional 2 academic years for first-time community college students and returning community college students who matriculate into upper division coursework of a community college baccalaureate degree program.

#### AB 3015 (Ramos D) Public postsecondary education: exemption from nonresident tuition and fees: federally recognized Indian tribes.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would entitle a student to resident classification only for the purpose of determining tuition and fees if the student is a member of a federally recognized Indian tribe whose tribal land lies across the state border of California and Arizona, Nevada, or Oregon, and the student has a residence in the bordering state.

#### SB 916 (Seyarto R) Public postsecondary education: waiver of tuition and fees: veterans: extended education courses.

Location: 8/15/2024-A. DEAD

**Summary:** This bill would prohibit the campuses of the 3 segments of public postsecondary education from charging tuition or fees for students who are dependents of certain veterans and who enroll in an extended education course if certain requirements are satisfied and the extended education course is being used to meet the requirements of undergraduate degree program.

#### **Financial Aid**

#### AB 25 (McCarty D) Student financial aid: Middle Class Scholarship Program.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would prohibit the Student Aid Commission, the University of California, the California State University, and a community college operating a baccalaureate degree program from considering any basic needs emergency aid in the awarding or adjusting of MCSP awards. It would also state Legislative intent to fully fund the Cal Grant Equity Reform.

#### AB 320 (Lee D) Student Aid Commission.

Location: 8/31/2024-S. DEAD

**Summary:** This bill would require the Student Aid Commission to include 4 student members rather than 2, one from each of the following: the University of California, the California State University, the California Community Colleges, and a California private postsecondary educational institution.

#### AB 1542 (Fong, Mike D) Board of Governors of the California Community Colleges: student members: Student Success Completion Grant program awards.

Location: 7/2/2024-S. DEAD

**Summary:** This bill would award Community Colleges Student Success Completion Grant program awards to student members of the board of governors.

#### AB 1793 (Ta R) Student financial aid: Cal Grants: Middle Class Scholarship Program: eligibility: dependents of members of the armed services stationed outside of California.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would extend Cal Grant and MCSP eligibility to a student who was not a resident of California at the time of high school graduation or its equivalent but meets all other applicable eligibility requirements and is a natural or adopted child, stepchild, or spouse who is a dependent of a member of the Armed Forces of the United States stationed outside of California on active duty but otherwise maintains their residence in California.

#### **AB 1839** (Alanis R) Peace officers: education and hiring grants.

**Location:** 5/16/2024-A. DEAD

**Summary:** This bill, subject to an appropriation, would establish the Law Enforcement Officer Grant Program under the administration of the Student Aid Commission to provide grants of up to \$6,000 per year to individuals enrolled in a modern policing degree program at a California community college who commit to work for 4 years as a peace officer at a law enforcement agency. The bill would require grant recipients to agree to repay the grant to the state if certain conditions for the grant are not met.

#### AB 2027 (Gipson D) Student financial aid: College Access Tax Credit Fund: community college student transfers: partnered Historically Black Colleges and Universities.

**Location:** 5/16/2024-A. DEAD

**Summary:** This bill would require the College Access Tax Credit Fund moneys continuously appropriated to the commission to also be used for awards for qualifying community college student transfers to certain Historically Black Graduate Professional Schools that are physically located in California and offer undergraduate studies.

#### AB 2184 (Davies R) Student financial aid: Cal Grant C and Cal Grant 2.

Location: 5/16/2024-A. DEAD

**Summary:** his bill, upon appropriation in the annual Budget Act for this purpose, would set, commencing with the 2025–26 award year, the maximum per-student Cal Grant C award amount at no less than double the maximum per-student Cal Grant C award amount provided for the 2023–24 award year. The bill would also require the prorated Cal Grant award and the per-student Cal Grant 2 access award amounts to be no less than double the maximum award amounts provided for the 2023–24 award year.

#### AB 2586 (Alvarez D) Public postsecondary education: student employment.

Location: 9/22/2024-A. VETOED

**Summary:** This bill would prohibit a University of California, California State University, or California Community College campus from disqualifying a student from being eligible to apply for an employment position at the campus due to their failure to provide proof of federal work authorization, except where that proof is required by federal law or where that proof is required as a condition of a grant that funds the particular employment position for which the student has applied. This bill would provide that, for its purposes, each campus of the University of California, the California State University, and the California Community Colleges is required to treat a specified prohibition in federal law on hiring unauthorized aliens as inapplicable because that provision of federal law does not state that it applies to any branch of state government. The bill would further provide that, to the extent student employment is considered a "benefit" for purposes of federal law, the bill constitutes authorization to provide that benefit for purposes of specified federal law.

#### (Committee on Budget and Fiscal Review) Personal Income Tax Law: exclusion: student loan debt: discharge of fees: higher education emergency grants.

**Location:** 8/31/2024-A. DEAD

**Summary:** Would exclude from an individual's gross income, for taxable years beginning on or after January 1, 2022, and before January 1, 2027, any amount relating to the discharge of unpaid fees due or owed by a student pursuant to that law.

#### SB 307 (Ashby D) Middle Class Scholarship Program: community colleges: current and former foster youth.

Location: 7/2/2024-A. DEAD

**Summary:** This bill would extend awards under the MCSP to community college students who are current or former foster youth pursuing transfer to a 4-year postsecondary educational institution, an associate degree, an associate degree for transfer, or a community college career technical education certificate and meet other MCSP requirements.

#### SB 971 (Portantino D) Community colleges: exemption from nonresident tuition fee: resident of a region impacted by war or regional conflict.

Location: 9/28/2024-S. VETOED

**Summary:** This bill would exempt from the nonresident tuition fee a nonresident, low-income student who: (1) is a resident of a region impacted by war or other regional conflict, (2) registers for lower division courses at a community college, and (3) has indicated that they have sought residency in California in an effort to find relief from identified conflicts in their nation of origin. The bill would, in any academic year, prohibit more than 150 full-time equivalent students at a community college from being exempted from payment of the nonresident tuition fee pursuant to this exemption.

#### SB 1483 (Wilk R) Cal Grant Program.

**Location:** 8/31/2024-S. DEAD

Summary: This bill would make a nonsubstantive change to the provision that establishes the Cal

Grant Program.

#### Housing

#### AB 1657 (Wicks D) The Affordable Housing Bond Act of 2024.

Location: 8/31/2024-S. DEAD

**Summary:** This bill would enact the Affordable Housing Bond Act of 2024, which, if adopted, would authorize the issuance of bonds in the amount of \$10,000,000,000 pursuant to the State General Obligation Bond Law. Proceeds from the sale of these bonds would be used to finance programs to fund affordable rental housing and homeownership programs.

#### AB 2707 (Fong, Mike D) Community colleges: student housing: study.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would require the Legislative Analyst's Office to conduct a study evaluating the age demographics of housing-insecure community college students to identify the issues and unique barriers that community college students 25 years of age and older face in securing housing. The bill would require the Legislative Analyst's Office to submit a report to the Legislature, on or before January 1, 2027, with the results of the study, including policy recommendations.

#### Miscellaneous

#### AB 252 (Holden D) The College Athlete Protection Act.

Location: 7/2/2024-S. DEAD

**Summary:** This bill would establish the College Athlete Protection (CAP) Act for purposes of providing various rights, benefits, and protections to college athletes. The bill instead would require certain institutions of higher education to establish a degree completion fund for its college athletes, as provided. The bill instead would require an institution of higher education to distribute to each college athlete a notice containing college athlete rights and would require the institution to post this notice in a conspicuous location frequented by college athletes, as specified. The bill instead would prohibit an institution of higher education, its employees, coaches, and affiliated medical personnel, as defined, from retaliating against a college athlete for filing a complaint or reporting a violation of college athlete rights provided in the CAP Act.

#### AB 1160 (Pacheco D) Protecting Students from Creditor Colleges Act.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would prohibit a school from refusing to provide a diploma or certificate for a current or former student on the grounds that the student owes a debt, conditioning the provision of a diploma or certificate on the payment of a debt, charging a higher fee for obtaining a diploma or

certificate or providing less favorable treatment of a diploma or certificate request because a student owes a debt, or using a diploma or certificate issuance as a tool for debt collection. The bill would prohibit a school from engaging a third-party debt collection agency to collect an existing or future student debt or selling an existing or future student debt to a third party. This bill would also prohibit an institution of higher education from placing an enrollment or registration hold on a current or former student's account, on the grounds that the student owes an institutional debt. The bill would require the governing boards of institutions of higher education, and request the office of the President of the University of California, to require each institution to report, on an annual basis, specified information regarding the number and dollar amount of institutional debts at each institution.

#### AB 2497 (Wallis R) Postsecondary education: segments.

Location: 5/2/2024-A. DEAD

**Summary:** This is a spot bill that would make nonsubstantive changes in a provision that, for purposes of the Donahoe Higher Education Act, designates the segments of public postsecondary education as the California Community Colleges, the California State University, and the University of California, as specified, and defines independent institutions of higher education for these purposes.

#### AB 3034 (Low D) Public postsecondary education: waiver of tuition and fees: California Conservation Corps.

Location: 9/22/2024-A. VETOED

**Summary:** This bill would prohibit the campuses of the California State University and the University of California from charging mandatory systemwide tuition or fees, as specified, for students who meet certain requirements, including having completed one year in the California Conservation Corps. The bill would apply to the campuses of the University of California only to the extent that the regents, by appropriate resolution, make it apply.

#### AB 3052 (Ta R) California Community Colleges.

Location: 5/2/2024-A. DEAD

**Summary:** This bill would state the intent of the Legislature to enact subsequent legislation relating to the California Community Colleges.

#### AB 3081 (Arambula D) Public postsecondary education: University of California, Merced: medical education.

**Location:** 8/31/2024-A. DEAD

**Summary:** The bill would, on or before July 1, 2025, and each July 1 thereafter, appropriate \$15,000,000 from the General Fund to the Regents of the University of California for allocation to the University of California, Merced, Medical Education Collaborative. The bill would require the University of California, Merced, Medical Education Collaborative, as a condition of receiving the appropriation, to develop a program, consistent with its mission, and in conjunction with the health facilities of its medical residency programs, to identify eligible medical residents and to assist those medical residents in applying for physician retention programs.

#### SB 308 (Becker D) Net zero greenhouse gas emissions goal: carbon dioxide removal: regulations. Location: 8/15/2024-A. DEAD

**Summary:** This bill would enact the Carbon Dioxide Removal Market Development Act that would require the state board, no later than December 31, 2027, to adopt a regulation to require certain emitting entities to purchase negative emissions credits equal to a specified amount of their greenhouse gas emissions, as determined by the state board, in each calendar year beginning in the 2028 calendar year in accordance with specified requirements. The bill would require the state board, no later than December 31, 2027, to establish rules and processes for certifying carbon dioxide removal processes that may be used to create negative emissions credits and for tracking negative emissions credits in accordance with certain criteria. The bill would also require negative emissions

resulting from the use of negative emissions credits to be included in the calculation of the state's net

greenhouse gas emissions.

#### **SB 906** (Skinner D) Collegiate athletics: student athlete compensation.

Location: 9/30/2024-S. VETOED

**Summary:** This bill would require any entity that provides compensation or any item of value or service to a student athlete, or to the student athlete's immediate family, to disclose specified information to the student athlete's postsecondary educational institution.

#### SB 1222 (Alvarado-Gil R) Community colleges: study: Counties of Amador, Alpine, Mariposa, Modoc, and Sierra.

**Location:** 5/16/2024-S. DEAD

**Summary:** This bill would declare that all the state's territory be included within a community college district by eliminating the exception that excludes certain counties from that policy. It further it would require the Legislative Analyst's Office (LAO) to prepare a report with specific policy recommendations to the legislature evaluating postsecondary education services and opportunities for residents of Amador, Alpine, Mariposa, Modoc, and Sierra counties that are not fully included in a community college

district. Lastly, the bill would require that the LAO convene and consult a working group to help prepare the report and recommendations.

#### Retirement

#### SB 252 (Gonzalez D) Public retirement systems: fossil fuels: divestment.

Location: 7/2/2024-A. DEAD

**Summary:** This bill would prohibit the boards of the Public Employees' Retirement System and the State Teachers' Retirement System from making new investments or renewing existing investments of public employee retirement funds in a fossil fuel company.

#### **Student Services**

#### AB 1543 (Fong, Mike D) Community colleges: student representation fees.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would require the other \$1 of the \$2 student representation fee to be used to establish and support the operations of local student body organizations. The bill would also require a community college to provide a student a means to refuse to pay either \$1 portion of the \$2 student representation fee.

#### **Teacher Training**

#### SB 995 (Padilla D) California State University: High-Quality Teacher Recruitment and Retention Act.

**Location:** 8/15/2024-A. DEAD

**Summary:** This bill would enact the High-Quality Teacher Recruitment and Retention Act. The bill would require the Chancellor of the California State University to develop, in consultation with the Chancellor of the California Community Colleges, a 5-year pilot program to commence with the 2025–26 school year to recruit high-quality teaching candidates at 3 California State University campuses in partnership with 3 community college campuses. The bill would require the pilot program to meet certain requirements, including, among other requirements, that it establish transfer model curriculum and an associate degree for transfer at a community college campus that can then be completed at a California State University campus that will result in the participating student being awarded a baccalaureate degree and a teaching credential in 4 years.

#### **Transfer**

#### AB 1749 (McCarty D) Student Transfer Achievement Reform Act: University of California.

**Location:** 8/15/2024-S. DEAD

**Summary:** This bill would require the office of the President of the University of California to develop a guaranteed transfer admission program that would, commencing with the 2025–26 school year, guarantee students who earn an associate degree from a California Community College admission to at least one University of California campus, as provided. The bill would require the president's office to establish minimum total coursework requirements and coursework requirements applicable to specific academic programs necessary for guaranteed transfer admission program eligibility. The bill would also require the president's office to adopt policies to determine the campus or campuses to which eligible students have earned guaranteed admission and develop an application process and informational materials in time to allow eligible students to enroll by the start of the 2025–26 academic year.

#### AB 2953 (Alvarez D) Public postsecondary education: University of California and California State University: first-generation college students: outreach and admission.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would require the California State University, and would request the University of California, to develop and implement a 4-year accountability plan for outreach to, and admission of, first-generation students to the segment, as specified. The bill would require the California State University, and would request the University of California, to submit an annual report to the Assembly Committee on Education, the Assembly Committee on Higher Education, and the Senate Committee on Education on the implementation and ongoing administration of the accountability plan.

#### SB 1200 (Glazer D) California State University students: California Promise: Finish in Four and Through in Two.

**Location:** 8/15/2024-A. DEAD

**Summary:** This bill would rename the California Promise program the Finish in Four and Through in Two program, as provided. The bill would require the Trustees of the California State University, on or before July 1, 2025, and annually thereafter, to submit a report to the Legislature that includes specified program participation information. The bill would delete an obsolete reporting requirement. The bill would delete the January 1, 2026, program repeal date, thereby extending the program indefinitely.

#### **Workforce Development**

#### AB 1370 (Ta R) California Community Colleges Economic and Workforce Development Program.

Location: 8/15/2024-S. DEAD

**Summary:** This bill would revise and recast several provisions of the California Community Colleges Economic and Workforce Development Program. The bill would extend operation of the program indefinitely and would repeal the Job Development Incentive Training Program. The bill would revise and recast the principles governing the Economic and Workforce Development Program, provisions on the duties and membership of the program's advisory committee, the decision criteria for allocating program funds to colleges, and the definitions that apply to the program's provisions.

#### AB 1922 (Davies R) California Conservation Corps: Green Collar Certification Program.

Location: 5/16/2024-A. DEAD

**Summary:** his bill would require the Director of the California Conservation Corps to establish a Green Collar Certification Program that provides young persons participating in the corps with skills and education relating to reducing carbon emissions in residential and nonresidential buildings, preparing communities for environmental disasters, and developing conservation infrastructure projects that stabilize shorelines and restore ecological habitats, as provided. The bill would require the director to issue a Green Collar Certificate to a corpsmember who successfully completes the program. The bill would authorize the director to apply for and accept grants or donations of funds from any public or private source that are provided for specified purposes relating to the program. The bill would establish the Green Collar Certification Program Fund and would require the grants or donations described above to be deposited into the fund.

#### AB 2076 (McCarty D) California Student Housing Revolving Loan Fund Act of 2022: state fund loan.

**Location:** 8/15/2024-S. DEAD

**Summary:** This bill would require the Controller to transfer \$200,000,000 to the California Student Housing Revolving Loan Fund from the Surplus Money Investment Fund and other funds in the Pooled Money Investment Account that accrue interest to the General Fund as a cash loan, for purposes of funding, commencing with the 2024–25 fiscal year, the program supported by the California Student Housing Revolving Loan Fund. The bill would require the loan principal and interest to be fully repaid on or before June 30, 2029.



## Let's Make College & Career Education More Affordable



## Streamline Access to Local and State Resources for College Affordability and Self-Sufficiency

- SBCCD is committed to putting students on the path to self-sufficiency and career success by supporting streamlined referral systems and data-sharing between local and state public agencies and community colleges.
- By reducing red tape, improving government efficiency, and safeguarding student privacy, we can connect students to essential resources like financial aid, CalFresh, Medi-Cal, Covered California, and housing referrals.
- This approach eases financial burdens, improves college affordability, and strengthens pathways to degrees and career training. The result is a skilled workforce, the breaking of poverty cycles, and sustained economic growth in the Inland Empire.

## **Expand State Financial Aid to Strengthen the Talent Pipeline**

- Inland Empire families are struggling with the high cost of living, making college and career training feel out of reach. SBCCD supports expanding and simplifying financial aid for all California students and families, particularly adult learners who attend community college part-time but need help paying for skills training and industry-recognized career certificates.
- We advocate for funding and implementing the Cal Grant Equity
   Framework or similar efforts that ensure college is affordable, including support for Cal Grant C, which directly targets the unique needs of part-time adult learners pursuing fast-track career programs at our community colleges.
- Addressing the total cost of attending college—not just tuition but also books, housing, food, and transportation—is critical to helping students graduate, transfer to four-year universities, or complete career training. These steps reduce financial barriers, create opportunities, and build a skilled workforce that drives economic growth and strengthens California's future.



## Invest in Simplifying FAFSA and Expanding Pell Grants for a Skilled Workforce

- SBCCD supports federal policies that simplify financial aid access by reducing unnecessary complexity in the Free Application for Federal Student Aid (FAFSA). Streamlining FAFSA will ensure all eligible students—including those from low- and middle-income families, regardless of their parents' background—can access financial aid, making community college and career training more attainable. This approach empowers working adults, returning veterans, and students to strengthen our local economy.
- Additionally, SBCCD supports increased investments in the Pell Grant and passing the Bipartisan Workforce Pell Act to help adult learners. This act expands Pell Grant eligibility to high-quality, short-term workforce programs at community colleges, equipping students for indemand careers.

#### Promote Affordable Access to Textbooks and Learning Materials

partnerships that make textbooks and learning materials more affordable and accessible for students. By negotiating agreements with textbook companies to lower costs and expanding initiatives like open educational resources (OER), the Zero Textbook Cost initiative, textbook rental programs, and digital access options, we can reduce financial burdens on students. These efforts help ensure students have the tools to succeed in their studies and develop the skills essential for the workforce.



## Let's Prepare Students for Good-Paying Careers



#### Support \$10 Million for the San Bernardino Job Growth Corridor to Modernize Job Training Facilities

- Both the SBCCD Economic Development & Corporate Training Center and the San Bernardino Regional Emergency Training Center are in critical need of life and safety infrastructure improvements and space modernization to support hands-on training for first responders and essential industry jobs.
- SBCCD is seeking \$10 million to create the San Bernardino Job Growth Corridor, a revitalization project to modernize job training facilities located in the neighborhood adjacent to San Bernardino International Airport, the former Norton Air Force Base. These upgrades will revitalize the community, address regional job training needs, and equip a skilled workforce to drive economic growth.

## Expand Bachelor's Degrees at Community Colleges for High-Need Careers

- SBCCD supports expanding bachelor's degree offerings at community colleges to prepare students for high-demand careers. Currently, Crafton Hills College offers a bachelor's in Respiratory Care, and San Bernardino Valley College offers one in Water Resources Management fields critical to our region's health and sustainability.
- Adding new bachelor's degree programs in other career fields will address regional workforce needs and strengthen partnerships with four-year universities to support student success.





## Strengthen Apprenticeships and California's Career Education Systems

- SBCCD supports the Governor's goal of creating 500,000 earn-and-learn apprenticeships by 2029 and advocates for funding to strengthen initiatives like the California Apprenticeship Initiative.
   Apprenticeship opportunities enable students to earn credit toward certificates or degrees through on-the-job training or classroom-based experiential learning—reducing the need to sacrifice income for education.
- Moreover, SBCCD supports the collaborative approach and core principles of the Master Plan for Career Education, which aims to modernize how education and workforce systems work together, ensuring learners gain skills and qualifications for high-opportunity careers.

## **Enhance Credit for Prior Learning to Support Adult Learners**

- SBCCD supports competency-based education and initiatives that allow adult learners to receive college credits based on their relevant work experience, making higher education more accessible and aligned with workforce needs.
- Additionally, SBCCD advocates ensuring that any "credit for prior learning" recognized by community colleges seamlessly transfers to University of California (UC) and California State University (Cal State) institutions. These efforts support students' career advancement and educational progress across California's higher education system.

## Support Fair Funding for Affordable Student Housing

- More than 50% of students at Crafton
  Hills College and San Bernardino Valley
  College face housing insecurity, and
  nearly 1 in 5 have experienced
  homelessness in recent years. However,
  state grant formulas to build affordable
  housing often prioritize coastal regions
  with a higher cost of living, putting Inland
  Empire colleges at a disadvantage.
- SBCCD advocates for adjustments to these formulas to ensure fair access to housing resources statewide. SBCCD also supports regional collaboration and publicprivate partnerships to address housing insecurity.

#### Expand CalFresh Access at Community College Cafeterias for a Healthy Future Workforce

- Hard-working community college
   students gaining career skills to become
   self-sufficient often struggle to access
   affordable, nutritious meals on campus.
   Current regulations classify college-owned
   and operated cafeterias with over 50%
   prepared foods as restaurants, restricting
   CalFresh/EBT usage despite their focus on
   healthy, accessible options. This creates
   unnecessary barriers for students who rely
   on CalFresh/EBT to meet basic needs.
- SBCCD advocates for an exemption
   allowing campus-owned dining facilities to accept CalFresh/EBT regardless of the percentage of prepared foods. This change would ensure students have access to affordable meals, helping them stay productive, complete their programs, and enter the workforce prepared.

  Expanding CalFresh/EBT access on campuses is an investment in California's talent pipeline, reducing barriers to success and strengthening our economy.

#### Building a Community of Respect, Belonging, and Opportunity

## Protect Funding for Community Colleges Under Proposition 98

 Proposition 98, passed in 1988, mandates a minimum state funding level for K-12 schools and California community colleges. We urge policymakers to protect state funding for community colleges. Ensuring community colleges receive their fair share of funding is essential to maintaining educational quality and accessibility.

#### **Provide CalSTRS/CalPERS Relief**

 SBCCD supports state funding to "buy down" employer contribution rates for CalSTRS and CalPERS. By reducing these costs, colleges can free up funds to invest in student programs, support services, and workforce training, directly benefiting students and the community.

## Ensure Emergency Preparedness and Immediate Relief for Our Community Colleges

- In times of crisis—such as wildfires,
   extreme heat, snowstorms, and pandemics
   —community colleges like SBCCD face
   significant challenges in maintaining
   operations and supporting students,
   faculty, and staff. Delays in accessing
   emergency funds can disrupt essential
   services, including broadband access, and
   hinder our ability to serve the community
   effectively during recovery.
- SBCCD supports partnerships and funding at all levels—local, state, federal, and public-private—to quickly address the safety and technology needs of our campuses. Securing rapid access to emergency resources ensures our colleges remain operational during crises and emerge stronger, ready to drive the Inland Empire's recovery and growth.





#### Support the CCC's 2025-26 Systemwide Budget Request

• SBCCD supports the California Community Colleges' 2025-26 systemwide budget request, which seeks \$152.8 million in ongoing and \$213.1 million in one-time funding. This investment aligns with Vision 2030 and the Governor's Roadmap for the Future by ensuring stable base funding, strengthening faculty support, and expanding flexible academic and career pathways. These initiatives are critical to equipping students with the skills needed to thrive in California's workforce and contribute to the state's economic growth.

## Strengthening KVCR: A Public Media Asset for the Inland Empire

- SBCCD owns and operates KVCR, the Inland Empire's nonprofit public media outlet, providing free community news, educational TV for children, and documentaries on history and science through TV channel 24, radio 91.9 FM, and online at kvcr.org. As the headquarters of FNX, the nation's only TV channel dedicated to Native American and World Indigenous programming, KVCR delivers unique content that reflects and enriches our diverse community. Our broadcast signal also serves a critical role in delivering emergency alerts to the region, ensuring public safety.
- Local, state and federal investment is essential to enhance KVCR's ability to keep our neighbors informed, educated, and connected. This funding will sustain and grow a vital resource that serves the Inland Empire and beyond.
