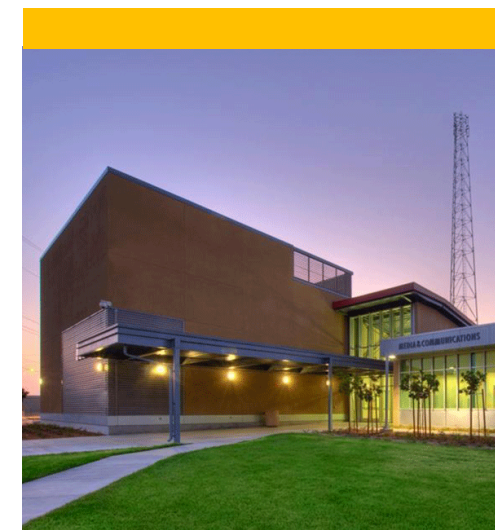
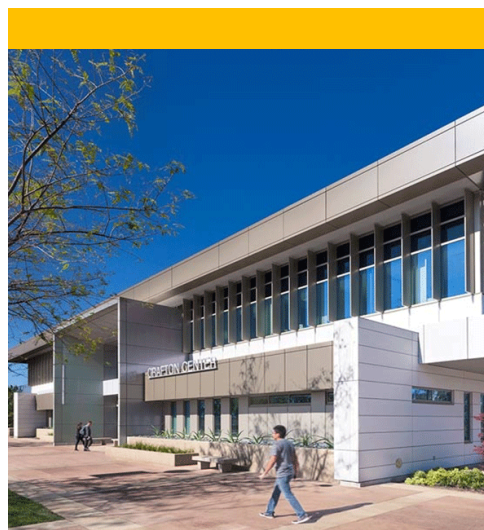
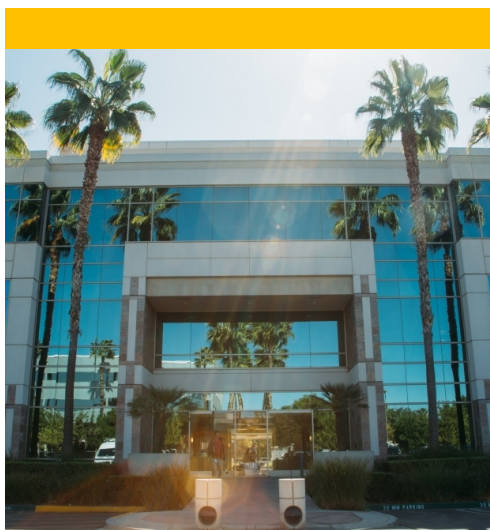

# Legislative Tracking

## TRACKED LEGISLATION

### **AB 1171 (Patel) - Part-Time Community College Faculty Health Insurance Program.**

**Summary:** This bill would revise and recast the Part-Time Community College Faculty Health Insurance Program to, among other things, provide that all part-time faculty and multidistrict part-time faculty are eligible to participate and require community college districts to reimburse a part-time faculty member for health insurance benefits, as specified.

**Status:** 1/29/26 – Senate Rules

**Fiscal Impact:** Ongoing Proposition 98 General Fund cost pressures potentially in the tens of millions to low hundreds of millions of dollars annually to expand the Program to all eligible part-time faculty.

**Support:** Faculty Association of California Community Colleges

**Opposition:** None on file

**District Recommendation:** Tracking

### **SB 960 (Cabaldon) - Public postsecondary education: community colleges: statewide baccalaureate degree program.**

**Summary:** This bill would prohibit a community college district from offering a baccalaureate degree program or program curricula already offered by the University of California, or a campus of the California State University whose local admission area includes, or overlaps with, the territory of the community college district, unless the California State University program has been impacted for 3 consecutive years before the date the program is approved.

**Status:** 2/3/26 – Senate Rules

**Fiscal Impact:** Unknown

**Support:** None on file

**Opposition:** None on file

**District Recommendation:** Tracking

# Legislative Tracking

## TRACKED LEGISLATION

### **AB 713 (Solache) - Public postsecondary education: student employment.**

**Summary:** This bill would prohibit the University of California, California State University, or California Community Colleges from disqualifying a student from being hired for an employment position due to their failure to provide proof of federal work authorization, except under specified circumstances.

**Status:** 1/29/26 – Senate Rules

**Fiscal Impact:** Significant General Fund cost exposure, potentially in the tens of millions to hundreds of millions of dollars, to the extent this bill results in litigation and a legal judgement implicating one or all of California's public colleges and universities regarding federal work authorization requirements.

**Support:** UC Student Association

**Opposition:** None on file

**District Recommendation:** Tracking

### **AB 805 (Fong) - Public postsecondary education: community colleges: statewide baccalaureate degree program.**

**Summary:** This bill would establish the Career Apprenticeship Bridge Program managed by the Division of Apprenticeship Standards within the Department of Industrial Relations. The program aims to coordinate apprenticeships for individuals aged 16 to 24, both in-school and out-of-school, and to create a streamlined youth apprenticeship data system to support data-driven decision-making. The bill also requires collaboration with the State Department of Education and the Chancellor's Office of California Community Colleges to set up program guidelines.

**Status:** 2/3/26 – Senate Rules

**Fiscal Impact:** Initial costs of an unknown amount, potentially in the low millions of dollars

**Support:** Society of Human Resources Management

**Opposition:** None on file

**District Recommendation:** Tracking

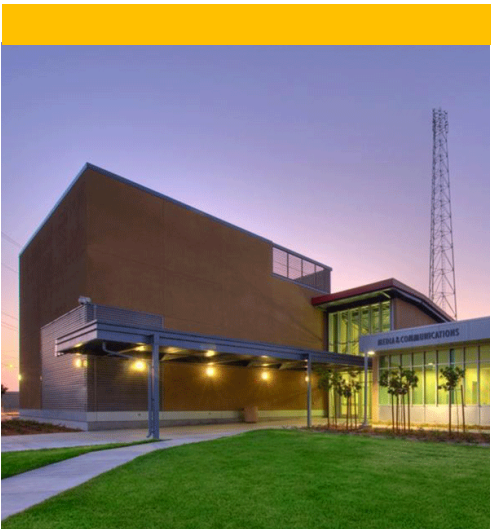
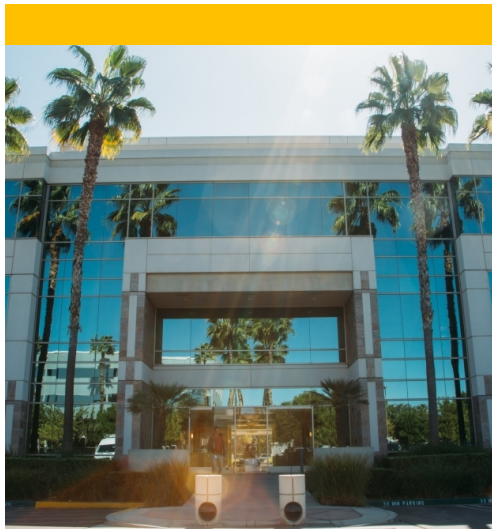
