Representation

Members will:

- Maintain and promote a focus that is based on district strategic priorities rather than personal, constituency or college interests.
- Represent constituency with accuracy and truthfulness, presenting data as completely as possible and not selectively withholding information.
- Communicate a clear understanding of the issues and any DBAC recommendations to their constituency.

- Solicit input from and disseminate information to their respective constituency group.
- Base interpersonal behavior on the assumption that we are all people of goodwill, ensuring that interactions within and outside the DBAC meetings are consistent with expectations of discretion and respect for individual and institutional integrity.
- Honor and acknowledge the contributions of individuals as well as the accomplishments of the whole team, regardless of the level of controversy in the discussion or its outcome.

Quorum

- 50%+1 of appointed voting members (not 50% of appointed members + vacancies), and
- Two members from each site (CHC, SBVC, and DSO members), and
- One faculty member from each site (CHC and SBVC), and
- Three out of the four Constituent Groups represented (students, classified, faculty, management).

Subcommittee quorum structure (if needed, not mandatory) will be unique and established by the overriding advisory committee.

I. Welcome & Introductions

Jose Torres brought the meeting to order shortly after 2:05 p.m.

II. DBAC Self Evaluation

Members of the committee were asked to complete the self-evaluation survey.

III. Approval of Minutes

A. Confirm a Quorum

Quorum was confirmed.

B. Approve Minutes of April 20, 2023

Mike Strong made a motion to approve the minutes, which Karen Peterson seconded. The motion passed by a unanimous vote.

IV. Current Topics

State Budget Update & SBCCD Tentative Budget

Jose advised the committee that the Governor's State Budget May Revision was not the final word, and that there will be much negotiation between now and the final budget. Staff is analyzing the data and sharing the latest information with DBAC.

Larry Strong presented the Fiscal Update to committee members. One item of particular concern is the "reappropriation" of funds allocated in 2022-23, which are now being taken back to balance the State's 2023-24 budget. These funds have already been earmarked by SBCCD to support students through the Books+ free books program. The District will be working with CCC partners and our consultant to advocate for the rejection of the May Revision proposed reductions to Deferred Maintenance, and the COVID-19 Block Grant. Jose asked that the DBAC members advocate among their constituent groups and any other bodies for the same.

Mike advised that the COVID-19 funds, which were being held in reserve until the other COVID grants had been exhausted in June, were to be used to help and encourage students to continue their education and stay in school. The loss of deferred maintenance funds would affect many planned projects, some of which have already started. This will impact facilities and possibly the Measure CC program.

Committee members discussed how the 8.22% COLA increase translates into actual revenue. Since it is the rate that is increasing, SBCCD will only be compensated for the number of FTES, which does not necessarily equate to a like percentage increase in revenue.

Jose commented that staff will be working to advocate for the State to reverse the decision to reappropriate funds. Our students are the number one priority, and we are committed to free tuition and Books+ for the summer.
