Discussion: This project was heavily outreached for by the District Initiatives Office (DIO). The Project Manager Advertised in both the Sun and Press and all Minority Papers four (4) times (12/17 & 24/2015 and 01/21 & 28/2016). The first Mandatory Job Walk was held on **01/05/16** and seventy-four (74) contractors attended; forty-one (41) identified as Primes and twenty-five (25) identified as Sub's; thirty-five (35) were local contractors; eleven (11) were MBE; six (6) were WBE; and four (4) were DVBE. The second Mandatory Job Walk was held on **01/29/16** and twenty-seven (27) contractors attended; eight (8) identified as Primes and twelve (12) identified as Sub's; eighteen (18) were local contractors; two (2) were MBE; and one (1) was a WBE. During the Mandatory Job Walks all Contractors participated in the Meet the Prime event. The Project Managers were asked to give the District Initiatives Office and the CBA Administrators the three (3) lowest bidders for assessment against BP6610 and the CBA Agreement below is the Unofficial Results and the final outcome for the three (3) lowest bidders. (Assessments and District Initiative Office Memo (DIOM) were emailed to Chancellor Baron and Vice Chancellor Torres for review).

Percentage of work being committed (in dollars) to local contractors is \$3,902,805 or 41.07%. The Bidder was found to adequately demonstrate responsiveness to the Good Faith Effort Requirements in BP6610, of the 19 Subcontractors reported on the Designation of Subcontractors Form, 8 were local (42.1%). Bidder's Overall Good Faith Efforts has demonstrated responsiveness and is therefore deemed responsive to Board Policy 6610 requirements. All required Forms, including Subcontractors List and Letter of Justification was provided within the specified Bid period. If Bidder is selected as lowest responsive Bidder, the Good Faith Effort Requirements are on-going and will be monitored throughout the life of the contract. At the time of this assessment there was 1-DVBE (Certified); 1-MBE(Certified); and 1-VOBE/WBE not certified.
