Last Meeting Notes:

- There is discussions on possibly changing the ‘Same-Day’ payment for SBVC, but for now we are going forward as if nothing will be changing.
- Dan as well as Financial Aid has submitted tickets on changes for AB540.
- In determining the best changes to the billing tables to support AB540 students, the following will be completed via the submitted tickets:
- **Recommended Changes for Billing:**
 - Copy over the AB540 Student Types to the existing AB540 field on XSTM1 (S02.STUDENTS).
 - If we can’t easily move the type dates, use the current date as the ‘From’ for AB540 students.
 - ?Remove the AB540 student types from SPRO?
 - This would remove the ability to run a student type report for AB540 students.
 - However, Informer can have a report quickly written to report the new AB540 students.
 - **Question:** Does MIS use this student type field for any reporting?
 - Create AB540 computed column to add to existing billing tables.
 - Create 8 additional billing tables to account for the new possible outcomes.
 - This process needs to be reviewed with Financial Aid.
- For now, Admissions (CHC) will be placing CNPD holds on AB540/Dream Act students, so they aren’t dropped until the billing is resolved. Also, Financial Aid will be asked to report the Dream Act student’s they have processed to Admissions so holds can be placed on new AB540 students.

Last Meeting Action Item: Will send out a separate e-mail to Admissions and Financial Aid to get feedback on the necessary changes, and if a separate ‘Dream Act’ flag will be necessary.
