Please accept this communication for review and discussion by the Chancellor's Council.

At its meeting on November 3, 2021, the IEAC members voted in favor to support the restructuring of the Planning & Program Review Subcommittee. The discussion leading to this recommendation included the points provided below:

- The requirement for quorum at the Chancellor's Council level suffices to ensure diversity, equity, and inclusion for all. There was a consensus that P&PR Subcommittee should be no more than 13 members to be effective.
- The DSO program review process is unique compared to the campus program review process. There was support in mirroring the campus' program review committee membership and reduce the membership to DSO members only.
- The current Planning & Program Review Subcommittee voted in favor to support the restructuring of the membership at the November 9, 2021, meeting. The subcommittee reports to IEAC which holds the proper constituency groups including campus and student representation.

Thank you for your consideration of this recommendation, which was approved as indicated below. We look forward to a response from Chancellor's Council.
