

Overview of the IEAC Process, Timeline, and Decision for Selecting an EMP Consultant

IEAC selected a committee to review applications

• **Members:** Dina Humble, Celia Huston, Davena Burns-Peters, Rania Hamdy, Gio Sosa, Keith Wurtz, Brandi Bailes, Christopher Crew, Joanna Oxendine

Committee selected CBT

- Cost \$296,000 (we budgeted for \$300,000)
- IEAC confirmed selection on November 3, 2021
- Approved by Board on December 10, 2021

Current Status

- Consultants started data gathering on December 15, 2021
- Consultants will meet with Chancellors Cabinet on February 2nd
- Meet with college EMPs in February and do kickoff meeting.

CRM and Single Point Application

- CRM (Customer Relations Management)
 - Technology for managing relationships and interactions with customers and potential customers
 - The goal is to improve business relationships
 - Help companies stay connected to customers, streamline processes, and improve profitability
- Single Point Application
 - Increase accessibility and completion rates of students
 - Need help analyzing the key business and instructional processes to identify the feasibility and the level of effort it would take to implement these changes

Summary:

- 1) The IEAC voted to reorganize the DSOPPRS to only include DSO employees in order to remove committee redundancy and improve institutional effectiveness.
- 2) All constituencies and 8 of 11 committee members representing the colleges, that were removed from the DSOPPRS, are already serving on the IEAC.
- 3) The IEAC has a charge to support the DSO program review process. As such, by extension, the colleges will remain involved in the DSO program review process but at a broader and more integrative level.
