2.	2018 Financial Aid Resubmission	A 2017-2018 Financial Aid resubmission has been made. With just a few errors to correct, the final version will be submitted later today.
3.	2019-2020 Academic Calendar Submission (End of Term Errors)	During my/the 2019-2020 Academic Calendar MIS submission an error was identified. May 22, 2020 was identified as the last day of the 2020 Spring term AND also an In-Service Day for graduation. Per the state a primary term day cannot also be an In-Service Day. The actual end date of the 2020 Spring term should be May 21, 2020, with May 22 as an In-Service Day for graduation.  Unfortunately there will need to be corrections made on a few fronts:  2019-2020 SBCCD Academic Calendar  Term dates for 2020SP in Colleague  All 2020SP term sections with an end date of May 22 will need to be updated with the correct end date of May 21, 2020.  Once the correction has been made to the 2019-2020 SBCCD Academic Calendar and board approved, I will be able to make the update in Colleague and re-submit the 2019-2020 academic calendar to the state.
