History of DSOPPRS Reorganization Vote

1. Chancellors Council changed the DSO shared governance committee structure

- **Purpose:** Include all SBCCD constituencies in shared governance process, improve transparency in decision-making, and ensure information is disseminated throughout the District
- Outcome: District Support Operations Program Review was made a subcommittee of IEAC

2. Membership was expanded to include all SBCCD constituencies

- Received communication from Chancellors Council that the expanded membership was only for the Advisory Committees
- 3. Proposal to split DSOPPRS into a Advisory Committee and a DSO Subcommittee was not supported by IEAC
 - Put forth a proposal to reduce membership of DSOPPRS to remove redundancy, improve committee efficiency, and give DSO autonomy over its program review process
 - Reduces membership but college involvement with DSOPPRS is maintained

8 of the 11 DSOPPRS members and all SBCCD constituency groups are on the IEAC

Concern raised about removing college representation from the DSOPPRS

• IEAC CHARGE:

 Providing program review support by reviewing program assessment results in light of District Support Operations (DSO) strategic goals to recommend institutional priorities for inclusion into integrated planning and resource allocation

• WHAT DOES THIS MEAN?:

- Gives IEAC jurisdiction over the DSO Program Review process and is more inline with the goals of Chancellor's Council (i.e., reporting up)
- The IEAC will set the parameters for what information it wants to review from the DSOPPRS

• OTHER TAKEAWAYS:

- DSOPPRS can be attended by non-members and any decision made at the DSOPPRS must be approved by the IEAC and Chancellor's Council before it can be implemented
- It's arguably better to have college representation on the IEAC where broad conversations about DSO service areas and resource allocation can take place (the original proposal)

Summary:

- 1) The IEAC voted to reorganize the DSOPPRS to only include DSO employees in order to remove committee redundancy and improve institutional effectiveness.
- 2) All constituencies and 8 of 11 committee members representing the colleges, that were removed from the DSOPPRS, are already serving on the IEAC.
- 3) The IEAC has a charge to support the DSO program review process. As such, by extension, the colleges will remain involved in the DSO program review process but at a broader and more integrative level.

Resource Request Timeline



- November 17 Resource Request Application and Resource Request Division Rankings forms are sent to district program managers.
- December 14 Resource Request Q&A. Any areas still working on requests were invited to attend.
- January 7 Resource Request Application and Resource Request Division Rankings due to District Program Review Committee Chair.
- January 11 Initial discussion, invite requestors to meeting to explain their needs.

Note:

We strongly believe that the resource request process needs to be improved. However, given the current transition happening with Chancellor's Council and the advisory committees, we will postpone this project until Spring 2022.

Justification Rubric:

In the interim, we will use the upcoming cycle of resource request submissions to see how the draft resource request justification rubric would apply.
