Recommendations:

Additional metric data is needed to determine if goals have been met.

Setting goals for the department can be difficult when staffing levels fluctuate from year to year. Improving response times is dependent on having adequate staffing levels, and it's preferable not to limit the department's ability to respond effectively. However, it's important to establish goals to demonstrate to the public that we're continuously working towards important objectives, even if we currently lack the necessary resources to achieve them.

Noting that the department will work toward industry standard response times also becomes a challenge since the standard comes from police departments outside the school district and is not a good comparison.

Goals will need to also include measurable data and timelines to show how and when the department goals have been accomplished.
