Brandi Bailes voiced concerns about the level 2 review schedule and non 10+1 designation regarding 3430 Prohibition of Harassment. The concern regarded the extensive amount of deletions to language that was previously reviewed in 2020. Kristina explained that changes to 3430 were made based on changes to Title IX on a Federal level that SBCCD has to comply with and 3430 is an overarching item that impacts all employees, it would not necessarily be designated as a 10+1 item. Discussion took place to take additional time to review the policy, due to Spring Break, and to designate 3430 Prohibition of Harassment as a 10+1 item.

Brandi Bailes made a motion to move 3430 Prohibition of Harassment to a level 3 review schedule from a level 2 review schedule, which Jessy Lemieux seconded. The motion did not pass with a vote of 6 to 5.

Kristina added that since 3430 Prohibition of Harassment will remain on a level 2 review schedule, the constituency groups are welcome to provide feedback after the next PPAC meeting if more time is needed to review this item.

Additionally, the Office of Human Resources can participate in consistency group meetings to further answer questions and clarify language.

A regular vote took place to affirm the review levels of items A.1.-A.3. and to continue moving all items through the review process. Keith Wurtz made a motion to affirm review levels and continue moving A.1. -A.3. through the review process which was seconded by Carmen Rodriguez. The motion was approved by majority vote.
