This "IT Think Tank" has over 600 specialists that provide research data and provide such services as consulting, contract review, product recommendations, etc. This contract will be used to provide background and foundational information to help guide decision-making. District Director of Research and Planning	A job descriptoin has been created for a District Director of Research and Planning. This position has been identified by the Chancellor, Vice-Chancellors, and College Presidents as a "high-priority" position. Ultimately, however, the filling of the position will be dependent on funding availability.	None
Datatel Access and Data Security	<p>The issue of student, short-term, and substitute access to Datatel was raised. The concern has to do with these temporary employees having access to sensitive information and the liability the District faces.</p> <p>As of August 1st, access to these three groups will be denied unless they provide proof of finger-printing.</p> <p>The group agreed that this was a short-term solution and raised additional concerns including: access to other systems (i.e. SARS), use of SSNs, and Data encryption. Alex stated that CHC Student Services is moving to only 19 hour permanent and regular employees having access to critical information systems. Damon will review the feasibility of this concept at SBVC.</p> <p>The group also discussed the lack of training related to data-security (i.e. FERPA/HIPAA</p>	<p>DCS to develop comprehensive list of where secure data/SSNs may be seen/accessed.</p> <p>Glen, Rick, and Wayne to review data-encryption software</p> <p>Glen to review training options for FERPA/HIPAA</p>
