I completely forgot about today's meeting due to the rush and work load of moving over to OUCampus. I apologize for not getting this email out sooner.

I would suggest that we hold this meeting over email as it would be informational at best. The information to cover is below. The only thing I can't answer for is if Kristi has any more items for Crafton's recent or future web projects. Yvette can also answer if there are any questions on the new ERP as she is the project manager.

- WCMS Replacement Progress
 - Valley & Crafton have launched their main sites in OUCampus as of 4/15 & 4/11, respectively
 - Valley is still working on 3 of their 4 department sites with the foundation launched on 4/21
 - Crafton is still working on SBRETC
 - District sites are next, after Valley is complete (as they share a Web Developer, Me).
 - I have heard talk at Valley trying to get their own Web Developer (finally! 😊)
- Student Portal Project
 - Nothing new yet. They are still trying to get input from other campuses and possible vendors.
- Recent and Future Web Projects
 - Both Kristi and I have been working on the OUCampus move since last meeting
 - I still have the following, after the OUCampus moves
 - SLOCloud for Student Services
 - Program Review for Valley
- Mass Email system in discussion
 - Two systems are currently being looked at, Regroup and Email Campaign Manager by OmniUpdate
 - Regroup is being looked at to replace Blackboard Connect's use for Emergency Notifications, but it also has mass mailing functionality. A demo is scheduled for May 5th.
 - Email Campaign Manager by OmniUpdate uses OUCampus for creating and managing email content and Campaign Monitor for sending emails and analytics. Donna, Kristi and I attended an online demo on 4/4 and it looked really easy to use.
 - Licensing may be a key factor as Regroup can do both Emergency Notifications and mass mailing, and that combination might the ROI on Regroup higher.
- Staff Directory discussions
 - A meeting was called to look at ways of improving the accuracy of the Staff Directory. It was decided to see if the new ERP system that uses ADP for HR and Payroll would have a solution to replace the current Staff Directory. This was mainly due to the fact that the inaccuracies of the current system are due to

the lack of integration with the current HR system. The current HR system is through county and they don't allow direct integration with our other systems.
