## AP 3516 REGISTERED SEX OFFENDER INFORMATION

The District shall include in its Annual Security Report a statement advising the campus community where information pertaining to registered sex offenders may be obtained. 13

Sex offenders are required to register with the police in the jurisdiction in which they reside 14 and at institutions of higher learning if they are students there or if they work there as 15 employees, contractors, or volunteers. A sex offender who is an employee or volunteer 16 in the District must disclose his/her status as a registrant upon his/her application or 17 18 acceptance of the position if he/she:

- 1) would be working directly and in an unaccompanied setting with minor children on more than an incidental and occasional basis or have supervision or disciplinary power over minor children or
- 2) would be working directly and in an accompanied setting with minor children and 22 his/her work would require touching minor children on more than an incidental 23 basis. 24

A sex offender who must register for committing a crime against a minor victim under the 26 age of 16 is prohibited from serving as an employer, employee, contractor, or volunteer 27 in any capacity in which the sex offender would be working directly and in an 28 unaccompanied setting with minor children on more than an incidental and occasional 29 basis or involving having supervision or disciplinary power over minor children. 30

The District Police Department shall not release information regarding a sex offender, 42 43 unless the person seeking the information has signed a statement, on a form provided by 44

the Department of Justice, stating that he/she is not a registered sex offender, that he/she

45 understands the purpose of the release of information is to allow members of the campus 46 community to protect themselves and their children from sex offenders, and that he/she understands it is unlawful to use the information received to commit a crime against any 47 registered sex offender or to engage in illegal discrimination or harassment of a registered 48 sex offender.
