



As well as beginning at the point of intersection of the Lake Arrowhead/San Bernardino census county division line and David Way, and proceeding easterly along the Lake Arrowhead/San Bernardino census county division line to unnamed Vehicular trail, and proceeding southerly along unnamed Vehicular trail to Rankins Ln E, and proceeding westerly along Rankins Ln E to David Way, and proceeding northerly along David Way to the point of beginning.
